20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is
23 hereby appropriated, to the Henderson State University, to be payable from
24 the General Improvement Fund or its successor fund or fund accounts, for the
25 Henderson State University the following:

26 (A) Effective July 1, 2011, the balance of the appropriation provided
27 in Item (B) Section 1 of Act 289 of 2010, for campus renovations, in a sum
28 not to exceed.....\$3,100,000.

29 (B) Effective July 1, 2011, the balance of the appropriation provided
30 in Item (C) Section 1 of Act 289 of 2010, for deferred maintenance, in a sum
31 not to exceed.....\$600,000.

32 (C) Effective July 1, 2011, the balance of the appropriation provided
33 in Item (D) Section 1 of Act 289 of 2010, for replacement/renewal of
34 equipment and library holdings, in a sum not to exceed.....\$50,000.
35

36 SECTION 2. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is
