24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. Arkansas Code § 6-63-305(b)(35), concerning the maximum
27 number of new or additional positions at the University of Arkansas Community
28 College at Hope, is amended to read as follows:

29 (35) University of Arkansas Community College at ~~Hope~~ Hope-
30 Texarkana 40

32 SECTION 2. Arkansas Code § 19-4-906(a)(135), concerning the maximum
33 authorized number of passenger motor vehicles in any year for University of
34 Arkansas Community College at Hope, is amended to read as follows:

35 (135) University of Arkansas Community College at ~~Hope~~ Hope-

SECTION 3. Arkansas Code § 19-5-303(v), concerning higher education funds used for maintenance, operation, and improvement at the University of Arkansas Community College at Hope, is amended to read as follows:

(v) University of Arkansas Community College at ~~Hope~~ Hope-Texarkana Fund.

(1) There is established on the books of the Treasurer of State, the Auditor of State, and the Chief Fiscal Officer of the State a fund to be known as the “University of Arkansas Community College at ~~Hope~~ Hope-Texarkana Fund”.

(2) The University of Arkansas Community College at ~~Hope~~ Hope-Texarkana Fund shall be used for the maintenance, operation, and improvement of the University of Arkansas Community College at ~~Hope~~ Hope-Texarkana.

(3) The University of Arkansas Community College at ~~Hope~~ Hope-Texarkana Fund shall consist of:

(A) Those general revenues as may be provided by law; and

(B) Any other funds made available for the support of the University of Arkansas Community College at ~~Hope~~ Hope-Texarkana which are required to be deposited into the State Treasury by law.

SECTION 4. Arkansas Code § 19-11-220(a)(35), concerning state agencies authorized to have an agency procurement official under the Arkansas Procurement Law, is amended to read as follows:

(35) University of Arkansas Community College at ~~Hope~~ Hope-Texarkana;

SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General Assembly of the State of Arkansas that the name change proposed under this act is to enable students interested in the Texarkana campus of the community college to have their ACT testing information sent directly to Texarkana and not to the Hope campus of the community college or to an institution in Texas; that there is confusion regarding where a student should send his or her ACT scores because Texarkana is not currently part of the campus’s formal name; and that this act is necessary in order to change the name of the community college in time for the next fiscal year. Therefore, an emergency is declared to exist, and this act being necessary

1 for the preservation of the public peace, health, and safety shall become
2 effective on July 1, 2019.
