## Subtitle

15 TO ABOLISH INACTIVE STATE ENTITIES; TO  
16 AMEND THE LAW CONCERNING THE REPORTING OF  
17 BOARDS AND COMMISSIONS; AND TO DECLARE AN

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. DO NOT CODIFY. Abolition of state entities, boards and  
25 commissions – Legislative findings.

26 (a) The General Assembly finds that the following state entities are  
27 no longer active and are abolished:

30 (b) Any funds, personal property, or real property of an entity under

34 (a) of this section shall end on the effective date of this act.
