## For An Act To Be Entitled

8 AN ACT TO ALLOW SCHOOL VOLUNTEERS TO ADMINISTER  
9 GLUCAGON TO STUDENTS FOR ANY TYPE OF DIABETES; TO  
10 CLARIFY AN INTERNAL REFERENCE IN THE INTERSTATE NURSE  
11 LICENSURE COMPACT; AND FOR OTHER PURPOSES.

## Subtitle

14 TO ALLOW SCHOOL VOLUNTEERS TO ADMINISTER  
15 GLUCAGON TO STUDENTS FOR ANY TYPE OF  
16 DIABETES; AND TO CLARIFY AN INTERNAL  
17 REFERENCE.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code § 17-87-103(11)(A) and (B), concerning  
24 exceptions to the nurse practice act, is amended to read as follows:

25 (11)(A) The administration of glucagon to a student who is  
26 suffering ~~from~~ with ~~type-1~~ diabetes by trained volunteer school personnel  
27 designated as care providers in a plan developed under Section 504 of the  
28 Rehabilitation Act of 1973, 29 U.S.C. § 701 et seq., as it existed on July 1,  
29 ~~2011~~ 2013, who have been trained by a licensed nurse employed by a school  
30 district or other health-care professional to administer glucagon to a child  
31 with ~~type-1~~ diabetes in an emergency situation.

32 (B)(i) A licensed nurse employed by a school district or  
33 other health-care professional shall annually train volunteer school  
34 personnel designated as care providers in a plan developed under Section 504  
35 of the Rehabilitation Act of 1973, 29 U.S.C. § 701 et seq., as it existed on  
36 July 1, ~~2011~~ 2013, to administer glucagon to a student with ~~type-1~~ diabetes.



1 (ii) The parent or guardian of a student with ~~type-1~~  
2 diabetes shall sign an authorization to allow the administration of glucagon  
3 to the student by volunteer school personnel designated as care providers.

4 (iii) The school district shall maintain a copy of  
5 the plan developed under Section 504 of the Rehabilitation Act of 1973, 29  
6 U.S.C. § 701 et seq., as it existed on July 1, ~~2011~~ 2013, a list of volunteer  
7 school personnel who are designated as care providers and trained to  
8 administer glucagon, and a copy of the parent's or guardian's signed  
9 authorization.

11 SECTION 2. Arkansas Code § 17-87-601, ARTICLE VIII(c) of the  
12 Interstate Nurse Licensure Compact, concerning compact administration and  
13 interchange of information under the Interstate Nurse Licensure Compact, is  
14 amended to read as follows:

15 (c) Compact administrators shall have the authority to develop uniform  
16 rules to facilitate and coordinate implementation of this Compact. These  
17 uniform rules shall be adopted by party states, under the authority invested  
18 under Article VI~~(d)~~.
