9 AN ACT TO AMEND THE LAW CONCERNING TEMPORARY  
10 PREPRINTED PAPER BUYER'S TAGS; AND FOR OTHER

### Subtitle

15 TO AMEND THE LAW CONCERNING TEMPORARY  
16 PREPRINTED PAPER BUYER'S TAGS.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code § 19-6-201(54), concerning general revenues  
22 enumerated, is amended to read as follows:

23 (54) The first ~~two dollars and fifty cents (\$2.50)~~ three dollars  
24 (\$3.00) of each unregistered vehicle temporary preprinted paper buyer's tag  
25 fee, § 27-14-1705;

27 SECTION 2. Arkansas Code § 27-14-1705(f)(1)(A), concerning temporary  
28 preprinted paper buyer's tags, is amended to read as follows:

29 (f)(1)(A) The buyer shall be responsible for paying to the director a  
30 fee to be set by the director, which shall not exceed ~~four dollars (\$4.00)~~  
31 five dollars fifty cents (\$5.50), for each temporary preprinted paper buyer's  
32 tag and any correlating sticker the buyer receives.  
33

34 SECTION 3. Arkansas Code § 27-14-1705(f)(3)(B), concerning temporary  
35 preprinted paper buyer's tags, is amended to read as follows:

36 (B) ~~All amounts~~ The amount in excess of the first ~~two dollars~~



1 ~~and fifty cents (\$2.50)~~ three dollars (\$3.00) of the fee collected under  
2 subdivision (f)(1)(A) of this section shall be deposited into the State  
3 Treasury, and the Treasurer of State shall credit them as cash revenue to the  
4 credit of the Revenue Division of the Department of Finance and  
5 Administration to offset administrative costs.

7 SECTION 4. EFFECTIVE DATE. This act is effective on and after  
8 November 13, 2017.
