23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Section 1 of Act 3 of the Regular Session of 2013 is hereby
26 amended to read as follows:

27 SECTION 1. APPROPRIATION - AUDITOR OF STATE DISBURSEMENTS. There is
28 hereby appropriated, to the Auditor of State, to be payable from the
29 Constitutional Officers Fund, for personal services and operating expenses of
30 the Auditor of State - General Appropriations for the fiscal year ending June
31 30, 2014, the following:

37 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the General

38 Assembly, that the Constitution of the State of Arkansas prohibits the

1 appropriation of funds for more than a one (1) year period; that the
2 effectiveness of this Act on July 1, 2013 is essential to the operation of
3 the agency for which the appropriations in this Act are provided, and that in
4 the event of an extension of the legislative session, the delay in the
5 effective date of this Act beyond July 1, 2013 could work irreparable harm
6 upon the proper administration and provision of essential governmental
7 programs. Therefore, an emergency is hereby declared to exist and this Act
8 being necessary for the immediate preservation of the public peace, health
9 and safety shall be in full force and effect from and after July 1, 2013.
