20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Arkansas Supreme Court for the 2016-2017 fiscal year, the following

23 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 24 the Arkansas Supreme Court for the 2016-2017 fiscal year, the following
 25 maximum number of part-time or temporary employees, to be known as "Extra
 26 Help", payable from funds appropriated herein for such purposes: five (5)
 27 temporary or part-time employees, when needed, at rates of pay not to exceed
 28 those provided in the Uniform Classification and Compensation Act, or its
 29 successor, or this act for the appropriate classification.

30

31 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 32 to the Arkansas Supreme Court, to be payable from the State Central Services
 33 Fund, for personal services and operating expenses of the Arkansas Supreme
 34 Court for the fiscal year ending June 30, 2017, the following:

 26 SECTION 6. EXTRA HELP - SUPREME COURT BAR OF ARKANSAS. There is hereby
 27 authorized, for the Arkansas Supreme Court - Bar of Arkansas for the 2016-
 28 2017 fiscal year, the following maximum number of part-time or temporary
 29 employees, to be known as "Extra Help", payable from funds appropriated
 30 herein for such purposes: five (5) temporary or part-time employees, when
 31 needed, at rates of pay not to exceed those provided in the Uniform
 32 Classification and Compensation Act, or its successor, or this act for the
 33 appropriate classification.

 35 SECTION 7. APPROPRIATION - SUPREME COURT BAR OF ARKANSAS. There is
 36 hereby appropriated, to the Arkansas Supreme Court, to be payable from cash

1 funds as defined by Arkansas Code 19-4-801 of the Arkansas Supreme Court, for
 2 personal services and operating expenses of the Arkansas Supreme Court - Bar
 3 of Arkansas for the fiscal year ending June 30, 2017, the following:

20 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ACCESS TO
 22 JUSTICE. The General Assembly finds that the Access to Justice Foundation
 23 serves a public purpose, therefore financial accounting, general bookkeeping,
 24 management and administrative services may be provided by employees of the
 25 Arkansas Supreme Court and the Supreme Court Bar of Arkansas in support of
 26 the Arkansas Access to Justice Foundation, Inc.

27 The provisions of this section shall be in effect only from July 1, ~~2015~~
 28 2016 through June 30, ~~2016~~ 2017.

29

30 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 31 authorized by this act shall be limited to the appropriation for such agency
 32 and funds made available by law for the support of such appropriations; and
 33 the restrictions of the State Procurement Law, the General Accounting and
 34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 35 Procedures and Restrictions Act, or their successors, and other fiscal
 36 control laws of this State, where applicable, and regulations promulgated by

1 the Department of Finance and Administration, as authorized by law, shall be
2 strictly complied with in disbursement of said funds.

3
4 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General
5 Assembly that any funds disbursed under the authority of the appropriations
6 contained in this act shall be in compliance with the stated reasons for
7 which this act was adopted, as evidenced by the Agency Requests, Executive
8 Recommendations and Legislative Recommendations contained in the budget
9 manuals prepared by the Department of Finance and Administration, letters, or
10 summarized oral testimony in the official minutes of the Arkansas Legislative
11 Council or Joint Budget Committee which relate to its passage and adoption.

12
13 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the
14 General Assembly, that the Constitution of the State of Arkansas prohibits
15 the appropriation of funds for more than a one (1) year period; that the
16 effectiveness of this Act on July 1, 2016 is essential to the operation of
17 the agency for which the appropriations in this Act are provided, and that in
18 the event of an extension of the legislative session, the delay in the
19 effective date of this Act beyond July 1, 2016 could work irreparable harm
20 upon the proper administration and provision of essential governmental
21 programs. Therefore, an emergency is hereby declared to exist and this Act
22 being necessary for the immediate preservation of the public peace, health
23 and safety shall be in full force and effect from and after July 1, 2016.
