2	23-81-903. Definitions.	
3	As used in this subchapter:	
4	(1)(A) "Contract" means an annuity contract in which an insurer:	
5	(i) Does not perform recordkeeping services; or	
6	(ii) Is not required to pay death benefits to any	
7	beneficiaries of a specific plan participant under the terms of the annuity	
8	contract.	
9	(B) "Contract" does not include an annuity contract that	
10	is used to fund an employment-related retirement plan;	
11	(2) "Death master file" means a comprehensive database or source	
12	of death information used to verify the death of an individual maintained by	
13	the Division of Vital Records of the Department of Health, the United States	
14	Social Security Administration, or other database or service;	
15	(3) "Death master file match" means locating a Social Security	
16	number or the name and date of birth of an insured, annuity owner, or	
17	retained asset account holder in a search of a death master file;	
18	(4) "Knowledge of death" means:	
19	(A) Receipt of an original or valid copy of a death	
20	certificate issued by the state or a political subdivision of the state; or	
21	(B) A death master file match validated by an insurer	
22	under § 23-81-904(c)(1)(A);	
23	(5)(A) "Policy" means a policy or certificate of life insurance	
24	issued in this state that provides a death benefit.	
25	(B) "Policy" does not include:	
26	(i) A policy or certificate of life insurance that	
27	provides a death benefit under:	
28	(a) A defined employee benefit pension plan,	
29	as defined in Section 3(35) of the Employee Retirement Income Security Act of	
30	1974, Pub. L. No. 93-406; or	
31	(b) Any federal employee benefit program;	
32	(ii) A policy or certificate of life insurance that	
33	is used to fund a preneed funeral contract or prearrangement;	
34	(iii) A policy or certificate of credit life or

36	(iv) A policy issued to a group master policyholder

2	(6) "Recordkeeping services" means services under a group policy
3	or contract between an insurer and a group policy or contract customer to
4	obtain, maintain, and administer on behalf of the insured a list of the
5	individuals who are insured under a group insurance contract or a line of
6	coverage including an individual's:
7	(A) Social Security number or name and date of birth;
8	(B) Beneficiary designation information;
9	(C) Coverage eligibility;
10	(D) Benefit amount; and
11	(E) Premium payment status; and
12	(7) "Retained asset account" means a mechanism to deposit the
13	settlement of proceeds payable under a policy or contract into a deposit
14	account where the proceeds are retained by the insurer or its agent under a
15	supplementary contract that only involves death benefits.

17	23-81-904. Insurer conduct.
18	(a) An insurer shall make a good faith effort to determine the death
19	of an insured upon receipt of knowledge of death.
20	(b)(1) An insurer shall compare an in-force policy, contract, and
21	retained asset account against a death master file to identify a potential
22	match to an insured covered under the policy, contract, and retained asset
23	account by using the full version of the death master file.
24	(2) An insurer shall perform the comparison under subdivision
25	(b)(1) of this section semiannually by using the death master file update.
26	(c)(1) For a potential match that is identified as a result of a death
27	master file match, the insurer shall within ninety (90) days of a death
28	master file match:
29	(A) Make a good faith effort to document and confirm the
30	death of the insured or retained asset account holder against other available
31	records and information;
32	(B) Determine if death benefits are due under an
33	applicable policy or contract; and
34	(C) If death benefits are due under the applicable policy
35	or contract:
36	(i) Make a good faith effort to document and locate

T	any beneficiary or beneficiaries; and
2	(ii) Provide the beneficiary or beneficiaries the
3	necessary claim form or instructions to make a claim under the policy or
4	contract including submitting a death certificate issued by the state or any
5	political subdivision of the state if required under the policy or contract.
6	(2) If an insurer is unable to confirm the death of an
7	individual under subdivision (c)(l) of this section, the policy, annuity, or
8	retained asset account may be considered by an insurer to be in force
9	according to the terms of the policy, annuity, or retained asset account.
10	(3) An insurer is required to confirm a possible death of an
11	insured under a group life insurance if the insurer maintains for an
12	individual covered under a policy or certificate an insured's:
13	(A) Social Security number or name and date of birth;
14	(B) Beneficiary designation information;
15	(C) Coverage eligibility;
16	(D) Benefit amount; and
17	(E) Premium payment status.
18	(4) To the extent permitted by law, an insurer may disclose the
19	necessary personal information about an insured or beneficiary to a person
20	who the insurer reasonably believes may be able to assist the insurer in
21	locating a beneficiary or a person entitled to payment of the claims
22	proceeds.
23	(d) An insurer shall not charge a beneficiary or the beneficiary's
24	authorized representative a fee or charge any costs associated with a death
25	master file search or verification of a death master file match performed
26	under this section.
27	(e)(l) A benefit or any accrued contractual interest under a policy,
28	contract, or a retained asset account is payable to the designated
29	beneficiary or owner.
30	(2) If a beneficiary or owner cannot be found, the benefit or
31	any accrued contractual interest shall escheat to the state as unclaimed
32	property under the Unclaimed Property Act, § 18-28-201 et seq.
33	(3) Interest payable under § 23-81-118 shall not be payable as
34	unclaimed property under the Unclaimed Property Act, § 18-28-201 et seq.
35	(f) An insurer shall notify the Auditor of State upon the expiration
36	of the statutory time period for escheat that:

1	(1) A beneficiary under a life insurance policy, contract, or
2	retained asset account holder has not submitted a claim with the insurer; and
3	(2) The insurer has complied with subsection (b) of this section
4	and has documented its good faith effort to locate and notify a beneficiary
5	or retained asset account holder but has been unsuccessful.
6	(g) Upon delivery of a notice under subsection (f) of this section, an
7	insurer shall submit immediately any unclaimed benefits under a policy,
8	contract, or retained asset account, plus any applicable interest, to the
9	Auditor of State.
10	
11	23-81-905. Unfair trade practices.
12	(a) If an insurer fails to comply with this subchapter so frequently
13	as to be a general business practice, then it is a violation of this
14	subchapter and may be subject to the Trade Practices Act, § 23-66-201 et seq.
15	(b) A violation of this subchapter does not create a private right of
16	action.
17	
18	SECTION 2. DO NOT CODIFY. <u>Effective Date. Section 1 of this act is</u>
19	applicable to policies issued after June 30, 2016.
