4 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. YOUTH 6 SERVICES - COMMUNITY-BASED RESIDENTIAL PROGRAMS - RESTRICTIONS. The 7 Department of Human Services shall not contract or pay for community-based 8 residential programs within any municipality to house unrelated persons who 9 have been adjudicated delinquent of an act that would constitute a Class A 10 felony or higher or of a sexual offense or convicted of a Class A felony or 11 higher or sexual offense until the following conditions have been met:

Residents within one thousand (1,000) feet of the proposed location
 of the facility shall be notified by mail;

2. A public hearing shall be conducted in the community of the proposed location of the facility by the contract provider at least ten (10) days in advance of the contract's effective date. Notice of the hearing shall be made by mail to each of the residents within 1,000 feet of the proposed location of the facility. The notification requirement shall not apply to already existing facilities at already existing locations.

Provided further, upon establishment of such facilities within a particular municipality, the contract provider and the Department shall establish and implement a system to receive and respond to complaints and questions from residents of such municipality. In the event the Department and the provider fail to provide satisfactory communication as provided in this section to the residents, such facility may be declared a public nuisance by the municipality.

The provisions of this section shall be in effect only from July 1, 2010

30 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 32 OF FUNDS FOR THE JUVENILE OMBUDSMAN PROGRAM. 6 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 8 OF FUNDS FOR LOCAL JUVENILE DETENTION FACILITIES. The Chief Fiscal Officer 9 of the State shall transfer funds in an amount of \$400,000 for the fiscal 10 year ending June 30, 2011 2013 from the Department of Human Services - Youth 11 Services Fund Account to the Juvenile Detention Facilities Operating Fund to 12 fund the appropriation to the Department of Finance and Administration -13 Disbursing Officer for grants for operating expenses of local juvenile 14 detention facilities.

The amount of the funds transferred in the fiscal year ending June 30, 2011 2013 may be adjusted upon request of the Director of the Department of Human Services on a pro-rata basis with any reductions provided in the Revenue Stabilization Law from the July 1 Official Forecast of general revenue funding for the Division of Youth Services.

21 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. YOUTH 23 SERVICES - TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND EQUIPMENT. The Division of Youth Services is authorized to use the administrative operating 24 25 account for capital improvements to the physical plant and for the purchase 26 of capital equipment by the Mansfield Youth Services Facility operated by the 27 Department of Human Services, Division of Youth Services. The funds shall be 28 held by the Department of Human Services, Division of Youth Services from the 29 proceeds of the sale of timber that may be harvested from land owned by the 30 Division of Youth Services. All funds deposited and all expenses shall be 31 tracked separately. The harvesting of timber is specifically authorized to 32 provide funds to finance capital improvements to the physical plant and for 33 the purchase of major capital equipment by the Mansfield Facility from which 34 the timber is sold.

35 The Division of Youth Services shall report all income derived from the 36 sale of timber to the Chief Fiscal Officer of the State and the Arkansas

Legislative Council. Any contracts initiated for the harvesting and sale of
 timber shall be submitted to the Review Subcommittee of the Arkansas
 Legislative Council for prior review. All expenditures of funds derived from
 the sale of timber will be expended in accordance with relevant state
 purchasing laws.

REGULAR 10 11 SALARIES - CONTINGENT EDUCATIONAL SERVICES POSITIONS. If it has been 12 determined by the Director of the Department of Human Services that the 13 Division of Youth Services cannot continue a contract with a private provider 14 for educational services and deems it necessary to utilize Division staff to 15 provide the required educational services, the Division is authorized, to 16 seek the approval of the Chief Fiscal Officer of the State, the Governor and 17 the Arkansas Legislative Council or Joint Budget Committee, to utilize the 18 contingent educational services positions contained in this Act and to make 19 the appropriate transfers from the Residential Services Appropriation line 20 item contained in this Act to Regular Salaries, Personal Services Matching, 21 and various Maintenance and General Operations classifications.

22 There is hereby established for the Division of Youth Services -23 Contingent Educational Services Positions for the 2010-2011 2012-2013 fiscal 24 year, the following maximum number of regular employees whose salaries shall 25 be governed by the provisions of the Uniform Classification and Compensation 26 Act (Arkansas Code 21-5-201 et seq.), or its successor, and all laws 27 amendatory thereto.
