23	SECTION 4. EMERGENCY CLAUSE. It is found and determine	ed by the General
24	Assembly, that funds provided by the General Assembly for the	e operations of
25	the Office of the Treasurer of State are, due to unforeseen of	circumstances,
26	insufficient for the Office of the Treasurer of State to cont	inue to provide
27	essential governmental services; that the provisions of this	act will provide
28	the necessary monies for the Office of the Treasurer of State	e to continue
29	such services; and that a delay in the effective date of this	Act could work
30	irreparable harm upon the proper administration and provision	of essential
31	governmental programs. Therefore, an emergency is hereby decl	ared to exist
