29	Department of Corrections, East Arkansas Regional Unit; and

31	WHEREAS, Sgt. Wallace served the State of Arkansas during his career
32	through employment with the Arkansas Department of Corrections, the Helena -
33	West Helena Police Department, the Marvell Police Department, the Crittenden
34	County Sheriff's Department, the Marianna Police Department, and as a School
35	Resource Officer for the Marianna School District; and
