15 TO AUTHORIZE THE INTRODUCTION OF A  
16 NONAPPROPRIATION BILL TO AUTHORIZE THE  
17 ISSUANCE AND RENEWAL OF A SPECIAL LICENSE  
18 PLATE TO PROMOTE AND SUPPORT THE ARKANSAS  
19 DYSLEXIA SUPPORT GROUP.

22 BE IT RESOLVED BY THE SENATE OF THE 93RD GENERAL ASSEMBLY OF THE STATE OF  
23 ARKANSAS:

25 THAT Senator Clark is authorized to introduce a bill which as  
26 introduced will read substantially as follows:

28 "Title

29 AN ACT TO AUTHORIZE THE ISSUANCE AND RENEWAL OF A SPECIAL LICENSE PLATE TO  
30 PROMOTE AND SUPPORT THE ARKANSAS DYSLEXIA SUPPORT GROUP; AND FOR OTHER  
31 PURPOSES.

33 Subtitle

34 TO AUTHORIZE THE ISSUANCE AND RENEWAL OF A SPECIAL LICENSE PLATE TO PROMOTE  
35 AND SUPPORT THE ARKANSAS DYSLEXIA SUPPORT GROUP.



1 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

2  
3 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14 is amended  
4 to add an additional section to read as follows:

5 27-24-1431. Arkansas Dyslexia Support Group.

6 (a) The Director of the Department of Finance and Administration shall  
7 create and issue an Arkansas Dyslexia Support Group special license plate in  
8 the manner and subject to the conditions provided for under this subchapter.

9 (b) The Arkansas Dyslexia Support Group special license plate shall  
10 be:

11 (1) Designed by the Department of Finance and Administration in  
12 consultation with the Arkansas Dyslexia Support Group Incorporated; and

13 (2) Numbered consecutively.

14 (c) The procedures concerning costs for issuance under § 27-24-  
15 1404(c)(1)(A) shall apply.

16 (d) The department shall issue a special license plate under this  
17 section to a motor vehicle owner upon payment of:

18 (1) The fee required by law for registration of the motor  
19 vehicle;

20 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use  
21 contribution.

22 (B) The design-use contribution shall be remitted monthly  
23 to the Arkansas Dyslexia Support Group Incorporated to be used exclusively to  
24 promote and support the Arkansas Dyslexia Support Group Incorporated; and

25 (3)(A) A handling and administrative fee of ten dollars  
26 (\$10.00).

27 (B) The handling and administrative fee of ten dollars  
28 (\$10.00) shall be:

29 (i) Deposited into the State Central Services Fund  
30 for the benefit of the Revenue Division of the Department of Finance and  
31 Administration; and

32 (ii) Credited to the division as supplemental and in  
33 addition to all other funds that may be deposited for the benefit of the  
34 division.

35 (C) The handling and administrative fee shall not be  
36 considered or credited to the division as direct revenue.

1           (e)(1) A special license plate issued under this section may be  
2 renewed annually or replaced under the procedures set out in § 27-24-1405.

3           (2) However, the division shall remit the fees collected under §  
4 27-24-1405(b)(2) on a monthly basis to the Arkansas Dyslexia Support Group  
5 Incorporated."
