- 1 Amend printed bill, page 6, lines 9 and 10, strike "A CONDITIONAL  
2 PRESCRIPTION CERTIFICATE OR".
- 3 Page 6, line 12, strike "**Conditional prescription**" and substitute  
4 "**Prescription**".
- 5 Page 6, line 13, strike "CONDITIONAL".
- 6 Page 6, strike line 18 and substitute "AN APPROVED".
- 7 Page 6, lines 24 and 25, strike "APPROVED BY THE BOARD AND" and  
8 substitute "ANY EDUCATION AS SET FORTH IN RULES PROMULGATED BY  
9 THE BOARD WITH APPROVAL OF".
- 10 Page 7, line 14, strike "ONE YEAR" and substitute "TWELVE MONTHS".
- 11 Page 7, line 15, strike "TWO YEARS," and substitute "TWENTY-FOUR  
12 MONTHS,".
- 13 Page 7, strike lines 18 through 23 and substitute:
- 14 "(A) A ONE-TO-ONE, IN-PERSON SUPERVISED PRACTICUM, OF AT  
15 LEAST SEVEN HUNDRED FIFTY HOURS TREATING AT LEAST ONE HUNDRED  
16 FIFTY CLIENTS WITH".
- 17 Page 8, after line 1 insert:
- 18 "(B) INCLUDED IN THE THE SEVENTY HUNDRES FIFTY HOURS  
19 REQUIRED IN SUBSECTION (2)(a)(IV)(B) OF THIS SECTION AT LEAST AN  
20 EIGHTY-HOUR PRACTICUM IN OBSERVATIONAL CLINICAL ASSESSMENT AND  
21 PATHOPHYSIOLOGY UNDER THE SUPERVISION OF AN INDEPENDENTLY  
22 LICENSED PRESCRIBING PHYSICIAN; AND
- 23 (C) IF THE LICENSED PSYCHOLOGIST IS WORKING WITH PEDIATRIC  
24 OR GERIATRIC PATIENTS, AT LEAST TWO HUNDRED FIFTY OF THE SEVEN  
25 HUNDRED FIFTY HOURS REQUIRED IN SUBSECTION (2)(a)(IV)(B) OF THIS  
26 SECTION UNDER THE SUPERVISION OF ONE OR MORE INDEPENDENT  
27 LICENSED PRESCRIBING CLINICIANS WHO WORK WITH PEDIATRIC OR  
28 GERIATRIC PATIENTS, WHICHEVER IS APPLICABLE, IF THE LICENSED  
29 PSYCHOLOGIST IS WORKING WITH PEDIATRIC OR GERIATRIC PATIENTS;".
- 30 Page 8, strike lines 2 through 27.

- 1 Page 9, strike lines 1 through 20 and substitute:
  - 2 "(V) HAS SUCCESSFULLY UNDERGONE A PROCESS OF INDEPENDENT
  - 3 PEER REVIEW AS SET FORTH IN RULE OF THE BOARD AND APPROVED BY THE
  - 4 COLORADO MEDICAL BOARD;"
- 5 Renumber succeeding subsections accordingly.
- 6 Page 9, line 21, strike "(III)" and substitute "(VI)".
- 7 Page 9, line 27 strike "(IV)" and substitute "(VII)".
- 8 Page 10, line 4, strike "(3)(a)" and substitute "(2)(a)".
- 9 Page 10, line 10, strike "(3)(a)(III)" and substitute "(2)(a)(VI)".
- 10 Page 11, lines 5 and 6, strike "A CONDITIONAL PRESCRIPTION CERTIFICATE
- 11 AND".
- 12 Page 11, strike line 10 and substitute "REVOCATION OF A".
- 13 Page 11, strike lines 15 and 16 and substitute "PSYCHOLOGIST MAY:".
- 14 Page 14, lines 23 and 24, strike "OR LICENSED PSYCHOLOGIST WITH A
- 15 CONDITIONAL PRESCRIPTION CERTIFICATE".
- 16 Page 15, strike lines 9 through 20 and substitute "PRESCRIBING
- 17 PSYCHOLOGIST SHALL COMPLY WITH APPLICABLE STATE AND FEDERAL
- 18 LAWS.".
- 19 Renumber succeeding subsections accordingly.
- 20 Page 15, lines 22 and 23 strike "AND LICENSED PSYCHOLOGIST WITH A
- 21 CONDITIONAL PRESCRIPTION CERTIFICATE".
- 22 Page 16, strike lines 5 through 7 and substitute:
  - 23 "(I) THE NUMBER OF PRESCRIBING PSYCHOLOGISTS IN THIS
  - 24 STATE;"
- 25 Page 16, strike lines 9 and 10 and substitute "PSYCHOLOGIST;"
- 26 Page 16, line 11, strike "AND LICENSED".
- 27 Page 16, strike line 12 and substitute "WHO".

- 1 Page 16, line 16, strike "PSYCHOLOGIST" and substitute "PSYCHOLOGIST;
- 2 AND".
  
- 3 Page 16, strike lines 17 and 18.
  
- 4 Page 16, strike lines 20 and 21 and substitute "PSYCHOLOGIST."
