Second Reading

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, 12-245-224, **add** (3)  
3 as follows:

4 **12-245-224. Prohibited activities - related provisions -**  
5 **definition.** (3) (a) THE BOARD SHALL DESIGN AND SEND A  
6 QUESTIONNAIRE TO ALL LICENSED PSYCHOLOGISTS WITH PRESCRIPTIVE  
7 AUTHORITY WHO APPLY FOR LICENSE RENEWAL. EACH APPLICANT FOR  
8 LICENSE RENEWAL SHALL COMPLETE THE BOARD-DESIGNED  
9 QUESTIONNAIRE. THE PURPOSE OF THE QUESTIONNAIRE IS TO DETERMINE  
10 WHETHER A LICENSEE HAS ACTED IN VIOLATION OF THIS PART 2 OR HAS  
11 BEEN DISCIPLINED FOR ANY ACTION THAT MIGHT BE CONSIDERED A  
12 VIOLATION OF THIS PART 2 OR THAT MIGHT MAKE THE LICENSEE UNFIT TO  
13 PRACTICE PSYCHOLOGY WITH REASONABLE CARE AND SAFETY. THE BOARD  
14 SHALL INCLUDE ON THE QUESTIONNAIRE A QUESTION REGARDING  
15 WHETHER THE LICENSEE HAS COMPLIED WITH SECTION 12-30-111 AND IS  
16 IN COMPLIANCE WITH SECTION 12-280-403 (2)(a). IF AN APPLICANT FAILS  
17 TO ANSWER THE QUESTIONNAIRE ACCURATELY, THE FAILURE CONSTITUTES  
18 GROUNDS FOR DISCIPLINE UNDER THIS SECTION. THE BOARD MAY INCLUDE  
19 THE COST OF DEVELOPING AND REVIEWING THE QUESTIONNAIRE IN THE FEE  
20 PAID PURSUANT TO SECTION 12-245-205 OF THIS SECTION. THE BOARD  
21 MAY DENY AN APPLICATION FOR LICENSE RENEWAL THAT DOES NOT  
22 ACCOMPANY AN ACCURATELY COMPLETED QUESTIONNAIRE.

23 (b) ON AND AFTER JULY 1, 2024, AS A CONDITION OF RENEWAL OF  
24 A LICENSE, EACH LICENSEE SHALL ATTEST THAT THE LICENSEE IS IN  
25 COMPLIANCE WITH SECTION 12-280-403 (2)(a) AND THAT THE LICENSEE IS  
26 AWARE OF THE PENALTIES FOR NONCOMPLIANCE WITH THAT SECTION."

27 Renumber succeeding sections accordingly.
