HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture, Water & Natural Resources.

HB24-1271 be amended as follows:

- 1 Amend printed bill, page 3, line 4, after "STATE" insert "OR UNDERSERVED
- 2 AND UNDER-RESOURCED CATEGORIES OF VETERINARY MEDICINE
- 3 PRACTICE".

- 4 Page 3, line 7, after "BUY" insert "OR START".

- 5 Page 4, line 2, before "VETERINARY" insert "MOBILE".

- 6 Page 4, line 17, after "BUYER" insert "WHO IS A LICENSED VETERINARIAN".

- 7 Page 4, line 22, after the period add "IF THE BUYER IS STARTING A NEW
- 8 PRACTICE, THE BUYER MUST PRACTICE FOR AT LEAST THREE YEARS IN THE
- 9 SAME PRACTICE."

- 10 Page 6, strike lines 4 and 5 and substitute "TWO COLORADO ANIMAL
- 11 PRODUCERS, OR THEIR REPRESENTATIVES, AND TWO COLORADO
- 12 NONPROFIT ORGANIZATIONS THAT UTILIZE VETERINARY SERVICES OR
- 13 THEIR REPRESENTATIVES. WHEN APPOINTING THE MEMBERS OF THE
- 14 ADVISORY COMMITTEE, THE STATE VETERINARIAN MUST, TO THE EXTENT
- 15 POSSIBLE, CHOOSE MEMBERS THAT REPRESENT DIVERSE CATEGORIES OF
- 16 VETERINARY MEDICINE PRACTICE."

- 17 Page 6, line 6, strike "TWO" and substitute "FIVE".

- 18 Page 6, line 12, after "AREAS" insert "OR WHICH PRACTICE CATEGORIES"
- 19 and strike "AN".

- 20 Page 6, line 13, strike "UNDER-RESOURCED AREA;" and substitute
- 21 "UNDER-RESOURCED;".

- 22 Page 6, line 20, strike "PRACTICE;" and substitute "PRACTICE OR BUYER OF
- 23 A NEW VETERINARY PRACTICE;".

- 24 Page 7, strike lines 2 and 3 and substitute:

- 25 "(VII) ONLY ONE TAX CREDIT MAY BE ISSUED TO A QUALIFIED
- 26 TAXPAYER THAT QUALIFIES PURSUANT TO SUBSECTION (3)(a)(II) or
- 27 (3)(a)(III) OF THIS SECTION."
