HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

HB24-1300 be amended as follows:

1 Amend printed bill, strike page 7.

2 Page 8, strike lines 1 through 6 and substitute:

3 "(2) (a) THE BOARD OF COUNTY COMMISSIONERS FOR EACH OF THE
4 AFFECTED COUNTIES MAY ESTABLISH BY ORDINANCE OR REGULATION A
5 PROGRAM TO REQUIRE WILDFIRE MITIGATION OF AN EXISTING RESIDENCE
6 OR STRUCTURE LOCATED IN A COUNTY MITIGATION AREA IN ACCORDANCE
7 WITH ONE OR MORE OF THE FOLLOWING:

8 (I) IBHS WILDFIRE MITIGATION STANDARDS;

9 (II) PHASE ONE WILDFIRE MITIGATION STANDARDS;

10 (III) PHASE TWO WILDFIRE MITIGATION STANDARDS; OR

11 (IV) OTHER STANDARDS AS DETERMINED BY THE COUNTY.

12 (b) A PROGRAM ESTABLISHED PURSUANT TO SUBSECTION (2)(a) OF
13 THIS SECTION MUST INCLUDE A WRITTEN POLICY AND PROCEDURE FOR A
14 HOMEOWNER TO SEEK A REASONABLE EXTENSION OF A PROGRAM
15 DEADLINE OR AN EXEMPTION FROM A PROGRAM REQUIREMENT ON THE
16 BASIS OF UNFORSEEN OR EMERGENCY CIRCUMSTANCES OR UNDUE BURDEN,
17 AS DETERMINED BY THE COUNTY.

18 (3) (a) EACH OF THE AFFECTED COUNTIES MUST POST ON A PUBLIC
19 WEBSITE A LIST OF INDIVIDUALS AND ENTITIES THAT PERFORM WILDFIRE
20 MITIGATION SERVICES IN THE COUNTY INCLUDING CONTACT INFORMATION
21 FOR ALL INDIVIDUALS AND ENTITIES LISTED. EACH AFFECTED COUNTY IS
22 ENCOURAGED TO INCLUDE ON THE SAME WEBSITE A COPY OF OR LINK TO:

23 (I) THE IBHS'S WILDFIRE-PREPARED HOME PROGRAM GUIDE, OR A
24 SUCCESSOR PUBLICATION;

25 (II) THE FOREST SERVICE'S PUBLICATION "THE HOME IGNITION
26 ZONE", OR A SUCCESSOR PUBLICATION;

27 (III) THE FOREST SERVICE'S WEB-BASED CLEARINGHOUSE FOR
28 TECHNICAL ASSISTANCE AND FUNDING RESOURCES CREATED PURSUANT TO
29 SECTION 23-31-313 (9); AND

30 (IV) COUNTY-SPECIFIC TECHNICAL ASSISTANCE AND FUNDING
31 RESOURCES FOR WILDFIRE MITIGATION BY HOMEOWNERS."
