HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1345 be amended as follows:

- 1 Amend printed bill, page 5, strike lines 9 through 11.
- 2 Reletter succeeding paragraph accordingly.
- 3 Page 5, line 14, strike "CHEMICALS." and substitute "CHEMICALS; AND
- 4 (b) AUTHORIZES THE DEPARTMENT TO REVIEW PRODUCTS AND
- 5 PRODUCT CATEGORIES THAT CONTAIN PFAS CHEMICALS AND MAKE
- 6 RECOMMENDATIONS TO THE STATE BOARD OF HEALTH CREATED IN
- 7 SECTION 25-1-103 (1) TO RESTRICT OR PROHIBIT THE PRODUCTION,
- 8 DISTRIBUTION, AND SALE OF PFAS CHEMICALS IN SPECIFIC CATEGORIES OF
- 9 PRODUCTS."
- 10 Page 6, strike lines 11 and 12 and substitute:
- 11 "(6) "CURRENTLY UNAVOIDABLE USE" MEANS".
- 12 Page 6, after line 22 insert:
- 13 "(8) "DIVISION" MEANS THE DIVISION OF ENVIRONMENTAL HEALTH
- 14 AND SUSTAINABILITY IN THE DEPARTMENT."
- 15 Renumber succeeding subsections accordingly.
- 16 Page 10, strike lines 16 and 17 and substitute "DIVISION HAS IDENTIFIED
- 17 AS A PRIORITY PRODUCT."
- 18 Page 10, strike lines 19 through 21 and substitute "CATEGORY THAT THE
- 19 DIVISION HAS IDENTIFIED AS A PRIORITY PRODUCT CATEGORY."
- 20 Page 11, strike lines 17 and 18 and substitute:
- 21 "(c) BASED ON AVAILABLE INFORMATION, IS REASONABLY
- 22 BELIEVED TO POSE LESS OF A HAZARD TO PUBLIC HEALTH AND THE
- 23 ENVIRONMENT THAN THE USE OF PFAS CHEMICALS."
- 24 Page 11, lines 19 through 21, strike "PEOPLE, AS IDENTIFIED BY THE
- 25 EXECUTIVE DIRECTOR BY RULE UNDER SECTION 25-5-1405 (2)(b)(III)," and
- 26 substitute "PEOPLE".
- 27 Page 12, strikes lines 3 and 4 and substitute "ANIMALS THAT ARE
- 28 DISPROPORTIONATELY OR".
- 29 Strike "(15)" and substitute "(16)" on: **Page 20**, lines 6 and 17.
