Committee on <u>Business Affairs & Labor</u>. HB24-1356 be amended as follows:

- 3 "SECTION 1. In Colorado Revised Statutes, 6-1-102, amend 4 (10) as follows:
  - **6-1-102. Definitions.** As used in this article 1, unless the context otherwise requires:
  - (10) "Sale" means any sale, offer for sale, or attempt to sell any real or personal PRODUCT, GOOD, OR property for any consideration.
- **SECTION 2.** In Colorado Revised Statutes, 6-1-105, **amend** 10 (1)(cccc) and (4) as follows:
  - 6-1-105. Unfair or deceptive trade practices definitions.

    (1) A person engages in a deceptive trade practice when, in the course of the person's business, vocation, or occupation, the person:
    - (cccc) Sells or offers for sale a product OR ELECTRONIC SMOKING DEVICE that is age-restricted to a person who does not meet the age restriction; or
    - (4) For purposes of AS USED IN this section, UNLESS THE CONTEXT OTHERWISE REQUIRES:
    - (a) (I) "ELECTRONIC SMOKING DEVICE" MEANS A NONCOMBUSTIBLE PRODUCT THAT PRODUCES VAPOR OR AEROSOL FOR INHALATION FROM THE APPLICATION OF A HEATING ELEMENT TO A LIQUID SUBSTANCE CONTAINING NICOTINE.
      - (II) "ELECTRONIC SMOKING DEVICE" INCLUDES:
    - (A) A CONSUMABLE NICOTINE LIQUID SUITABLE FOR USE IN AN ELECTRONIC SMOKING DEVICE, WHETHER SOLD WITH THE DEVICE OR SOLD SEPARATELY; AND
    - (B) A PRODUCT RELATED TO THE USE OF AN ELECTRONIC SMOKING DEVICE, SUCH AS A POWER UNIT, AN E-LIQUID, AN E-LIQUID CARTRIDGE, AN E-LIQUID POD, A DISPOSABLE DEVICE, OR ANY OTHER PRODUCT.
      - (III) "ELECTRONIC SMOKING DEVICE" DOES NOT INCLUDE:
  - (A) ANY PRODUCT THAT HAS BEEN APPROVED BY THE FEDERAL FOOD AND DRUG ADMINISTRATION FOR SALE AS A TOBACCO CESSATION PRODUCT OR FOR OTHER THERAPEUTIC USE IF THAT PRODUCT IS MARKETED AND SOLD SOLELY FOR SUCH APPROVED USE; OR
  - (B) AN ELECTRONIC SMOKING DEVICE DESIGNED AND USED FOR MARIJUANA OR A PRODUCT RELATED TO THE USE OF AN ELECTRONIC SMOKING DEVICE DESIGNED AND USED FOR MARIJUANA.
- 38 (b) "Recklessly" means a reckless disregard for the truth or falsity of a statement or advertisement.

- 1 **SECTION 3. Safety clause.** The general assembly finds,
- determines, and declares that this act is necessary for the immediate
- 3 preservation of the public peace, health, or safety or for appropriations for
- 4 the support and maintenance of the departments of the state and state
- 5 institutions.".
- 6 Page 1, strike lines 102 through 110 and substitute "DEVICES TO MINORS,
- 7 AND, IN CONNECTION THEREWITH, ESTABLISHING THE SALE OF
- 8 ELECTRONIC SMOKING DEVICES TO MINORS AS A DECEPTIVE TRADE
- 9 PRACTICE.".
