- 7 Page 11, line 9, strike "(3)(k)(III)" and substitute "(3)(l)(III)".
- 8 Page 11, after line 26 insert:

9 "(n) "ISOLATED ORDINARY HIGH WATERMARK REACHES" MEANS
10 REACHES OF STATE WATERS WITH AN ORDINARY HIGH WATERMARK THAT
11 ARE BORDERED UPSTREAM AND DOWNSTREAM BY UPLANDS.

(o) "ISOLATED PONDS AND IMPOUNDMENTS" MEANS PONDS AND
IMPOUNDMENTS THAT ARE NOT WITHIN THE ONE-HUNDRED-YEAR
FLOODPLAIN OR WITHIN ONE THOUSAND FIVE HUNDRED FEET OF AN
ORDINARY HIGH WATERMARK OF OTHER STATE WATERS. IN THE ABSENCE
OF ONE-HUNDRED-YEAR FLOODPLAIN MAPPING BY THE FEDERAL
EMERGENCY MANAGEMENT AGENCY, THE ONE THOUSAND FIVE HUNDRED
FEET DISTANCE CRITERION APPLIES.

19 "ISOLATED WETLANDS" MEANS WETLANDS WHOLLY (p) 20 SURROUNDED BY UPLANDS, WITH NO CONTIGUOUS SURFACE WATER 21 CONNECTION TO DOWNSTREAM STATE WATERS. "ISOLATED WETLANDS" 22 DOES NOT INCLUDE WETLANDS WHERE ANY PORTION OF THE WETLAND IS 23 WITHIN THE ONE-HUNDRED-YEAR FLOODPLAIN OR WITHIN ONE THOUSAND 24 FIVE HUNDRED FEET OF THE ORDINARY HIGH WATERMARK OF OTHER STATE 25 WATERS. IN THE ABSENCE OF ONE-HUNDRED-YEAR FLOODPLAIN MAPPING 26 BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY, THE ONE THOUSAND 27 FIVE HUNDRED FEET DISTANCE CRITERION APPLIES.

(q) "KETTLE PONDS" MEANS LAKES, PONDS, OR WETLANDS
LOCATED WITHIN A FORMERLY GLACIATED LANDSCAPE AND FORMED BY
ICE BLOCKS LEFT BY A RETREATING GLACIER.".
