- (f) "Water district" means a special district which supplies
 Water for domestic and other public and private purposes by any
 Available means and provides all necessary or proper
 Reservoirs, treatment works and facilities, equipment, and
 Appurtenances incident thereto.".

- (I) (A) EACH TREASURER SHALL CALCULATE, FOR EACH MUNICIPALITY, FIRE DISTRICT, WATER DISTRICT, SANITATION DISTRICT, AND LIBRARY DISTRICT, THE AGGREGATE REDUCTION OF LOCAL GOVERNMENT PROPERTY REVENUE DURING THE PROPERTY TAX YEAR COMMENCING ON JANUARY 1, 2023, AS A RESULT OF THE CHANGES MADE IN SENATE BILL 22-238, ENACTED IN 2022, THAT REDUCED VALUATIONS FOR ASSESSMENT SET FORTH PURSUANT TO SECTIONS 39-1-104 (1)(b) AND (1.8)(b), 39-1-104.2 (3)(q)(II) AND (3)(r)(II), AND 39-3-104.3 (2);
- (B) EACH ASSESSOR SHALL CALCULATE, FOR EACH MUNICIPALITY, FIRE DISTRICT, WATER DISTRICT, SANITATION DISTRICT, AND LIBRARY DISTRICT, THE AGGREGATE REDUCTION OF LOCAL GOVERNMENT PROPERTY TAX REVENUE DURING THE DIFFERENCE IN ASSESSED VALUE OF REAL PROPERTY FOR THE PROPERTY TAX YEAR COMMENCING ON JANUARY 1, 2022, AND THE PROPERTY TAX YEAR COMMENCING ON JANUARY 1, 2023, WITHIN THE TREASURER'S COUNTY; AND
