SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB23-287 be amended as follows:

- 1 Amend printed bill, page 20, line 27, strike "NO LATER THAN JULY 1,
2 2023".
- 3 Page 21, line 1, strike "THE COMMISSIONER" and substitute "THE
4 COMMISSIONER".
- 5 Page 23, strike lines 5 through 10 and substitute:
6 (3) THE TASK FORCE SHALL MEET AT THE CALL OF".
- 7 Page 23, line 11, strike "AT LEAST SIX TIMES" and substitute "NOT MORE
8 THAN EIGHT TIMES".
- 9 Page 23, line 12, after "2023." insert "MEETINGS MAY BE HELD IN PERSON,
10 THROUGH THE USE OF AUDIO-VISUAL COMMUNICATION TECHNOLOGY, OR
11 BOTH".
- 12 Page 23, line 27, strike "TASK FORCE FACILITATION, STAKEHOLDER" and
13 substitute "TASK FORCE FACILITATION AND STAKEHOLDER".
- 14 Page 24, line 1, strike "INPUT, AND SCHOOL FINANCE POLICY" and
15 substitute "INPUT".
- 16 Page 25, line 10, strike "DECEMBER 15, 2023," and substitute "JANUARY
17 31, 2024,".
- 18 Page 25, line 18, strike "NOT LATER THAN DECEMBER 15, 2023, THE" and
19 substitute "THE".
- 20 Page 25, line 23, strike "NOT LATER THAN FEBRUARY 1, 2024, THE" and
21 substitute "THE".
- 22 Page 26, line 8, strike "JANUARY 1, 2025," and substitute "JANUARY 3,
23 2025,".
- 24 Page 26, after line 13 insert:
- 25 "(9) ANY MONEY APPROPRIATED FOR THE 2023-24 BUDGET YEAR
26 BY THE GENERAL ASSEMBLY TO THE DEPARTMENT OF EDUCATION FOR THE
27 PURPOSES OF THIS SECTION THAT REMAINS UNSPENT AT THE END OF THE
28 2023-24 BUDGET YEAR MAY BE USED BY THE DEPARTMENT OF EDUCATION
29 THROUGH THE 2024-25 BUDGET YEAR WITHOUT FURTHER APPROPRIATION
30 AND MUST NOT BE USED FOR ANY OTHER PURPOSE THAN THE PURPOSES SET
31 FORTH IN THIS SECTION.".
