## JBC Staff Analysis

**Section 1** of the bill appropriates \$61,867,025 total funds for the Legislative Department for FY 2022-23, including:

- \$60,241,694 General Fund;
- \$90,000 cash funds; and
- \$1,535,331 reappropriated funds.

This section reflects a total of 421.0 FTE.

**Section 2** of the bill appropriates \$50,000 General Fund to the Youth Advisory Council Cash Fund for FY 2022-23. This cash fund is continuously appropriated to the Legislative Department for the costs of the Youth Advisory Council.

**Section 3** of the bill authorizes the Legislative Council to spend \$17,500 of its FY 2021-22 General Fund appropriation in FY 2022-23 for new member orientation.

More detailed information about the appropriations for each legislative agency is included in the March 4, 2022 booklet titled, "Colorado Legislative Branch: 2022-23 Fiscal Year Budget Request".

### **Description of Amendments in This Packet**

L.001 Bill Sponsor amendment L.001 (attached) reduces General Fund appropriations to the Legislative Department for FY 2022-23 by a total of \$447,219 to correct an error in the calculation of legislative aide compensation. If this amendment is adopted, General Fund appropriations in the bill for FY 2022-23 will total \$59,844,475.

### **Points to Consider**

### General Fund Impact

The Joint Budget Committee (JBC) is developing a budget package for FY 2022-23. The JBC has voted to include as part of its FY 2022-23 budget package a General Fund place holder to cover the appropriations included in this bill.
