Description of Amendments in This Packet

J.001 Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$21,264 General Fund to the Department of Law for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.2 FTE.

JBC Staff Analysis

L.005 Bill Sponsor amendment **L.005** (attached) provides the Department of Law flexibility to utilize existing resources to implement the bill.

The Committee may adopt amendment **J.001** or amendment **L.005** but should not adopt both.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$93.5 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$14.0 million).

This bill requires a General Fund appropriation of \$21,264 for FY 2024-25, reducing the \$93.5 million set aside by the same amount. If the Committee adopts amendment **L.005**, this impact is eliminated.
