**Fiscal Impact of Bill as Amended to Date**

**Current Appropriations Clause in Bill**

The bill requires but does not contain an appropriation clause.

**Description of Amendments in This Packet**

**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$448,082 General Fund for FY 2024-25, including \$286,135 to the Department of Higher Education for the Colorado State Forest Service at Colorado State University, and \$161,947 to the Department of Public Safety for FY 2024-25. This provision also states that the appropriation is based on the assumption that the Department of Higher Education will require an additional 0.4 FTE, and the Department of Public Safety will require an additional 1.6 FTE.

**L.003 and J.002**

Bill Sponsor amendment **L.003** (attached) strikes the portions of the bill pertaining to the Department of Public Safety responsibilities. Legislative Council Staff and JBC Staff agree this eliminates the appropriation for the Department of Public Safety identified in the Fiscal Note. Additionally, the number of grants assumed to be awarded is reduced from 5 to 3 in FY 2024-25, reducing the necessary appropriation to the Department of Higher Education by \$100,000.

Amendment **J.002** (attached) appropriates \$186,135 General Fund to the Department of Higher Education for use by the Colorado State Forest Service at Colorado State University in FY 2024-25. The provision also states that the appropriation is based on the assumption that the Department will require an additional 0.4 FTE.

**If the Committee Adopts L.003, it should adopt J.002 and should NOT adopt J.001.**

**Points to Consider**

*General Fund Impact*

The Joint Budget Committee has proposed a budget package for FY 2024-25 based on the March 2024 Office of State Planning and Budgeting (OSPB) revenue forecast. The budget package includes \$63.1 million in set-asides for legislation outside of the package (see table below). The budget package accounts for the 15.0 percent reserve associated with the placeholders (a total of \$9.5 million).
