A BILL FOR AN ACT

101 **CONCERNING THE BOARD OF DIRECTORS OF PINNACOL ASSURANCE.**

Bill Summary

Interim Committee to Study Issues Related to Pinnacol Assurance. The bill requires 2 employee members of the board of directors of Pinnacol Assurance (board) to be nonmanagement employees. Adds 2 additional members to the board: An injured worker and the executive director of the Colorado department of labor and employment or his or her representative.

The bill increases the per diem for the board members from \$140

6 **8-45-101. Pinnacol Assurance - creation - powers and duties.**

7 (5) The board shall:

8 (m) POST THE DATE, TIME, AND LOCATION OF EACH BOARD
9 MEETING ON THE PINNACOL ASSURANCE WEB SITE AT LEAST SEVEN
10 CALENDAR DAYS PRIOR TO THE SCHEDULED MEETING.

11 **SECTION 2. Effective date.** This act shall take effect July 1,
12 2010.

13 **SECTION 3. Safety clause.** The general assembly hereby finds,
14 determines, and declares that this act is necessary for the immediate
15 preservation of the public peace, health, and safety.
