1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** 2-5-126 (2), Colorado Revised Statutes, is amended 3 BY THE ADDITION OF A NEW PARAGRAPH to read: 4 2-5-126. Annual enactment of Colorado Revised Statutes -5 validation - effective date. (2) The annual statutes, copies of which 6 shall be delivered to each member of the general assembly, together with 7 a listing of the revisor's changes, constitute the official report of the 8 committee on legal services and are hereby enacted in accordance with 9 this section as follows: 10 (m) Colorado Revised Statutes 2009. COLORADO REVISED 11 STATUTES 2009, WHICH CONSISTS OF ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND PERMANENT NATURE ORIGINALLY 12 13 ENACTED IN "COLORADO REVISED STATUTES 1973", INCLUDING 14 SUBSEQUENT ENACTMENTS MADE PURSUANT TO SECTION 2-5-125, AND 15 ALL OF THE LAWS OF THE STATE OF COLORADO OF A GENERAL AND 16 PERMANENT NATURE ENACTED AT THE FIRST REGULAR SESSION OF THE 17 SIXTY-SEVENTH GENERAL ASSEMBLY. THE EFFECTIVE DATE FOR 18 COLORADO REVISED STATUTES 2009 IS FIXED AS THE FIRST DAY THAT IS 19 NOT A SATURDAY, SUNDAY, OR LEGAL HOLIDAY FOLLOWING THE 20 EFFECTIVE DATE OF THIS PARAGRAPH (m). 21 **SECTION 2. Safety clause.** The general assembly hereby finds, 22 determines, and declares that this act is necessary for the immediate 23 preservation of the public peace, health, and safety.
