## A BILL FOR AN ACT

101	CONCERNING PROMOTING BEHAVIORAL HEALTH CRISIS SERVICES TO
102	SCHOOL-AGE STUDENTS, AND, IN CONNECTION THEREWITH,
103	MAKING AN APPROPRIATION.

## **Bill Summary**

Colorado Youth Advisory Council Review Committee. The bill requires each student identification card issued to a public school student to contain the phone number, website address, and text talk number for the 24-hour telephone crisis service center (Colorado crisis services). display outreach materials from Colorado crisis services.

The bill requires that Colorado crisis services notify each public school in the state that it can provide outreach materials explaining the services provided, how to engage the services, and the possibility of peer-to-peer counseling as part of the offered services. Colorado crisis services shall provide those materials upon request.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, add 22-1-134 as
3	follows:
4	22-1-134. Student identification cards - information required.
5	EACH STUDENT IDENTIFICATION CARD ISSUED TO A PUBLIC SCHOOL
6	STUDENT MUST CONTAIN THE PHONE NUMBER, WEBSITE ADDRESS, AND
7	TEXT TALK NUMBER FOR COLORADO CRISIS SERVICES, AS DEFINED IN
8	SECTION 27-60-104, AND THE SAFE2TELL PROGRAM CREATED IN SECTION
9	24-31-606. The public school may also include information
10	REGARDING OTHER AVAILABLE CRISIS SERVICES ON THE IDENTIFICATION
11	CARD. IF A PUBLIC SCHOOL DOES NOT ISSUE STUDENT IDENTIFICATION
12	CARDS, THE PUBLIC SCHOOL SHALL DISPLAY THE MATERIALS DESCRIBED
13	IN SECTION 27-60-104 (10) AT THE SCHOOL AND SEND INFORMATION
14	RELATED TO COLORADO CRISIS SERVICES TO PARENTS OR GUARDIANS AT
15	THE BEGINNING OF EACH SCHOOL YEAR.
16	SECTION 2. In Colorado Revised Statutes, 27-60-104, add (10)
17	as follows:
18	27-60-104. Behavioral health crisis response system - crisis
19	service facilities - walk-in centers - mobile response units - report.
20	(10) (a) THE STATE DEPARTMENT SHALL ANNUALLY, IN AUGUST, NOTIFY
21	EACH PUBLIC AND PRIVATE SCHOOL IN THE STATE ABOUT SERVICES
22	PROVIDED BY THE BEHAVIORAL HEALTH CRISIS RESPONSE SYSTEM,

1	INCLUDING BUT NOT LIMITED TO HOW TO ENGAGE WITH AND WHAT TO
2	EXPECT FROM THE SERVICES, AND THE POSSIBILITY OF PEER-TO-PEER
3	COUNSELING AS A PART OF THE OFFERED SERVICES. THE STATE
4	DEPARTMENT SHALL PROVIDE BEHAVIORAL HEALTH CRISIS RESPONSE
5	SYSTEM AWARENESS AND EDUCATIONAL MATERIALS TO EACH PUBLIC AND
6	PRIVATE SCHOOL IN THE STATE.
7	(b) THE STATE DEPARTMENT SHALL COLLABORATE WITH THE
8	DEPARTMENT OF EDUCATION, CREATED IN SECTION 24-1-115, IN
9	IDENTIFYING PUBLIC AND PRIVATE SCHOOLS IN COLORADO, INCLUDING
10	BUT NOT LIMITED TO IDENTIFYING SCHOOL CONTACT INFORMATION.
11	<b>SECTION 3.</b> Appropriation. (1) For the 2022-23 state fiscal
12	year, \$\frac{\$267,065}{}\$ is appropriated to the department of human services for
13	use by the behavioral health administration. This appropriation is from the
14	general fund. To implement this act, the administration may use this
15	appropriation as follows:
16	(a) \$74,990 for program administration related to community
17	behavioral health administration, which amount is based on an
18	assumption that the administration will require an additional $\underline{0.9\mathrm{FTE}}$ and
19	(b) \$192,075 for the behavioral health crisis response system
20	public information campaign.
21	SECTION 4. Safety clause. The general assembly hereby finds,
22	determines, and declares that this act is necessary for the immediate
23	preservation of the public peace, health, or safety.
