A BILL FOR AN ACT

101 CONCERNING THE ESTABLISHMENT OF A CONTINUING PROFESSIONAL
102 DEVELOPMENT PROGRAM FOR LICENSED PSYCHOLOGISTS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill requires a licensed psychologist to complete continuing professional development and educational hours to maintain his or her license as a psychologist. The state board of psychologist examiners (board) is required to adopt rules establishing a continuing professional development program that includes:

! The development, execution, and documentation of a

learning plan;

- ! A requirement that every 2 years a psychologist complete at least 40 hours of continuing professional development; and
- ! A requirement that the psychologist maintain documentation of the continuing professional development hours.

The bill allows the board to audit up to 5% of licensed psychologists each 2-year cycle to determine compliance with the requirements. The bill clarifies that the records of assessments or other documentation in connection with the continuing professional development are confidential.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. Legislative declaration. The general assembly finds and declares that although there may be a shortage of mental health professionals in this state to serve the needs of the people who seek their help, it is important that licensed psychologists are involved in professional development activities that enhance their knowledge and skills in order to best meet the needs of Colorado. Therefore, it is the intent of the general assembly to require continuing professional development and education for licensed psychologists. In doing so, the general assembly encourages each psychologist to consider the current mental health needs or issues facing Colorado at the time when he or she is working on his or her professional development and education.

SECTION 2. In Colorado Revised Statutes, **add** 12-43-307 as follows:

12-43-307. Continuing professional development - rules. (1) IN ACCORDANCE WITH SECTION 12-43-304, THE BOARD ISSUES A LICENSE TO PRACTICE AS A PSYCHOLOGIST BASED ON WHETHER THE APPLICANT SATISFIES MINIMUM EDUCATIONAL AND EXPERIENCE REQUIREMENTS THAT DEMONSTRATE COMPETENCY TO PRACTICE AS A PSYCHOLOGIST. AFTER A

(5) (a) RECORDS OF ASSESSMENTS OR OTHER DOCUMENTATION DEVELOPED OR SUBMITTED IN CONNECTION WITH THE CONTINUING PROFESSIONAL DEVELOPMENT PROGRAM ARE CONFIDENTIAL AND NOT SUBJECT TO INSPECTION BY THE PUBLIC OR DISCOVERY IN CONNECTION WITH A CIVIL ACTION AGAINST A LICENSED PSYCHOLOGIST. THE RECORDS OR DOCUMENTS SHALL BE USED ONLY BY THE BOARD FOR THE PURPOSE OF DETERMINING WHETHER A LICENSED PSYCHOLOGIST IS MAINTAINING CONTINUING PROFESSIONAL DEVELOPMENT NECESSARY TO ENGAGE IN THE PROFESSION.

(b) Subject to the requirements of paragraph (a) of this subsection (5), nothing in this section shall be construed to restrict the discovery of information or documents that are otherwise discoverable under the Colorado rules of civil procedure in connection with a civil action against a licensed psychologist.

SECTION 3. Act subject to petition - effective date. This act takes effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 5, 2015, if adjournment sine die is on May 6, 2015); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part will not take effect unless approved by the people at the general election to be held in November 2016 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor.
