101 **CONCERNING ELIMINATION OF THE REQUIREMENT THAT A PERSON**
102 **EMPLOYED IN A TECHNICAL FORESTRY CAPACITY BY THE BOARD**

104 **POSSESS AT LEAST TWO YEARS' EXPERIENCE IN FOREST**

technical forestry capacity by the board of governors of the Colorado state university system possess a minimum of 2 years' experience in forest practice.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 23-31-207, Colorado Revised Statutes, is amended
3 to read:

4 **23-31-207. Employees and personnel.** The board is authorized
5 to employ ~~such~~ THE necessary professional, clerical, and other personnel
6 needed to carry out ~~the provisions of~~ this part 2. Persons employed in a
7 technical forestry capacity must have completed the requirements for and
8 received a degree from an accredited school of forestry. ~~and have had at~~
9 ~~least two years' experience in forest practice.~~ Persons employed in other
10 technical fields must have completed the requirements for and received
11 a degree from an accredited school in their professional field. The board
12 may appoint, pursuant to its personnel powers, in consultation with the
13 executive director of the department of natural resources, to carry out the
14 provisions of this part 2 and part 3 of this article, a professional forester,
15 to be known as the state forester, whose duties shall be primarily of an
16 educational or regulatory nature.

17 **SECTION 2. Safety clause.** The general assembly hereby finds,
18 determines, and declares that this act is necessary for the immediate
19 preservation of the public peace, health, and safety.
