Prior to taking any action to approve a national property documentation form (form) or to request the approval of the keeper of the national register of an executed form, the bill requires the state historical society to require the applicant to obtain the consent, evidenced by a notarized signature, of each owner of the land and property described in

8	REQUEST THE APPROVAL OF THE KEEPER OF THE NATIONAL REGISTER OF
9	AN EXECUTED MULTIPLE PROPERTY DOCUMENTATION FORM, THE SOCIETY
10	SHALL REQUIRE THE APPLICANT TO OBTAIN THE CONSENT, EVIDENCED BY
11	A SIGNATURE, OF EACH OWNER OF THE LAND AND PROPERTY INCLUDED
12	WITHIN THE REGION OF LANDS DESCRIBED IN THE FORM WHO PROVIDED
13	ANY INFORMATION OR GRANTED ACCESS TO THEIR LAND OR PROPERTY.
14	SECTION 2. Act subject to petition - effective date -
15	applicability. (1) This act takes effect at 12:01 a.m. on the day following
16	the expiration of the ninety-day period after final adjournment of the
17	general assembly (August 2, 2019, if adjournment sine die is on May 3,
18	2019); except that, if a referendum petition is filed pursuant to section 1
19	(3) of article V of the state constitution against this act or an item, section,
20	or part of this act within such period, then the act, item, section, or part
21	will not take effect unless approved by the people at the general election
22	to be held in November 2020 and, in such case, will take effect on the
23	date of the official declaration of the vote thereon by the governor.
24	(2) This act applies to applications for approval of a multiple
