A BILL FOR AN ACT

CONCERNING CRIMES RELATED TO MOTOR VEHICLES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

A person commits ownership or operation of a chop shop if he or she knowingly:

- ! Owns, operates, or conducts a chop shop as defined in the bill;
- ! Transports an unlawfully obtained motor vehicle or major component motor vehicle part to or from a chop shop; or
- ! Sells or transfers to, or purchases or receives from, a chop

shop an unlawfully obtained motor vehicle or major component motor vehicle part.

Ownership or operation of a chop shop is a class 3 felony.

The bill repeals and relocates crimes related to vehicle identification numbers or numbers on major motor vehicle component parts.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, add 18-4-420 as
3	follows:
4	18-4-420. Chop shop activity - ownership or operation of a
5	chop shop - altered or removed identification number - penalties -
6	definitions. (1) A PERSON COMMITS OWNERSHIP OR OPERATION OF A CHOP
7	SHOP IF HE OR SHE KNOWINGLY:
8	(a) OWNS OR OPERATES A CHOP SHOP, KNOWING THAT IT IS A CHOP
9	SHOP, OR CONSPIRES WITH ANOTHER PERSON TO OWN, OPERATE, OR
10	CONDUCT A CHOP SHOP, KNOWING THAT IT IS A CHOP SHOP;
11	(b) TRANSPORTS AN UNLAWFULLY OBTAINED MOTOR VEHICLE OR
12	MAJOR COMPONENT MOTOR VEHICLE PART TO OR FROM A CHOP SHOP,
13	KNOWING THAT IT IS A CHOP SHOP; OR
14	(c) Sells or transfers to, or purchases or receives from,
15	A CHOP SHOP, KNOWING IT IS A CHOP SHOP, AN UNLAWFULLY OBTAINED
16	MOTOR VEHICLE OR MAJOR COMPONENT MOTOR VEHICLE PART.

18	DISASSEMBLE, OR ALTER, INCLUDING THE ALTERATION OR CONCEALMENT
19	OF ANY IDENTIFYING FEATURE OR NUMBER, AN UNLAWFULLY OBTAINED
20	MOTOR VEHICLE OR MAJOR COMPONENT MOTOR VEHICLE PART FOR THE
21	PURPOSE OF USING, SELLING, OR DISPOSING OF THE MOTOR VEHICLE OR

4	(II) THE TRANSMISSION;
5	(III) THE RIGHT OR LEFT FRONT FENDER;
6	(IV) THE HOOD;
7	(V) ANY DOOR ALLOWING ENTRANCE TO OR EGRESS FROM THE
8	PASSENGER COMPARTMENT OF THE VEHICLE;
9	(VI) THE FRONT OR REAR BUMPER;
10	(VII) THE RIGHT OR LEFT REAR QUARTER PANEL;
11	(VIII) THE DECK LID, TAILGATE, OR HATCHBACK;
12	(IX) THE TRUNK FLOOR PAN;
13	(X) THE CARGO BOX OF A PICKUP TRUCK;
14	(XI) THE FRAME, OR IF THE VEHICLE HAS A UNITIZED BODY, THE

2	(d) "Unlawfully obtained" means obtained by theft,
3	FRAUD, OR DECEIT, OR OBTAINED WITHOUT THE PERMISSION OF THE
4	OWNER.
5	SECTION 2. In Colorado Revised Statutes, repeal 42-5-102.
6	SECTION 3. Potential appropriation. Pursuant to section
7	2-2-703, Colorado Revised Statutes, any bill that results in a net increase
8	in periods of imprisonment in the state correctional facilities must include
9	an appropriation of moneys that is sufficient to cover any increased
10	capital construction and operational costs for the first five fiscal years in
11	which there is a fiscal impact. Because this act may increase periods of
12	imprisonment, this act may require a five-year appropriation.
13	SECTION 4. Act subject to petition - effective date -
14	applicability. (1) This act takes effect at 12:01 a.m. on the day following
15	the expiration of the ninety-day period after final adjournment of the
16	general assembly (August 6, 2014, if adjournment sine die is on May 7,
17	2014); except that, if a referendum petition is filed pursuant to section 1
18	(3) of article V of the state constitution against this act or an item, section,
19	or part of this act within such period, then the act, item, section, or part
20	will not take effect unless approved by the people at the general election
21	to be held in November 2014 and, in such case, will take effect on the
22	date of the official declaration of the vote thereon by the governor.
23	(2) This act applies to offenses committed on or after the

applicable effective date of this act.
