A BILL FOR AN ACT

101 **CONCERNING THE QUALIFICATION FOR A PERSON TO USE THE 10TH**
102 **MOUNTAIN DIVISION LICENSE PLATE.**

Bill Summary

The bill requires the department of revenue to confirm that a person is qualified to have a "10th mountain division" license plate by making the issuance or renewal of the plate conditional upon the person's possession of a certificate from the sponsoring organization. The organization may require a specific level of contribution to qualify for the

plate. This is optional for "10th mountain division" license plates issued before the effective date of this act.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 42-3-208, **amend** (1) introductory portion; and **add** (1) (e) as follows:

42-3-208. Special plates - qualifications for issuance of special license plates. (1) The following special license plates created by rule by the department under section 42-3-207, as ~~such section~~ IT existed when the plates were created, ~~shall be~~ ARE subject to the FOLLOWING requirement: ~~so specified:~~

(e) (I) THE DEPARTMENT SHALL NOT ISSUE A "10TH MOUNTAIN DIVISION" LICENSE PLATE UNLESS THE APPLICANT PROVIDES A CERTIFICATE ISSUED BY THE 10TH MOUNTAIN DIVISION FOUNDATION, INC., OR A SUCCESSOR ORGANIZATION, CONFIRMING THAT THE PERSON MEETS THE QUALIFICATIONS ESTABLISHED BY THE FOUNDATION FOR THE LICENSE PLATE. THE 10TH MOUNTAIN DIVISION FOUNDATION, INC., MAY REQUIRE SPECIFIC LEVELS OF CONTRIBUTIONS OF NOT LESS THAN FIFTEEN DOLLARS AND NOT MORE THAN ONE HUNDRED DOLLARS TO QUALIFY FOR THE PLATE.

(II) ON OR AFTER JULY 1, 2017, THE DEPARTMENT SHALL NOT RENEW A "10TH MOUNTAIN DIVISION" LICENSE PLATE UNLESS THE PERSON MEETS THE QUALIFICATIONS ESTABLISHED BY THE 10TH MOUNTAIN DIVISION FOUNDATION, INC., OR A SUCCESSOR ORGANIZATION, TO RENEW THE LICENSE PLATE. THE 10TH MOUNTAIN DIVISION FOUNDATION, INC., MAY REQUIRE SPECIFIC LEVELS OF CONTRIBUTIONS OF NOT LESS THAN FIFTEEN DOLLARS AND NOT MORE THAN ONE HUNDRED DOLLARS TO RENEW THE PLATE.

SECTION 2. Act subject to petition - effective date -

1 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
2 the expiration of the ninety-day period after final adjournment of the
3 general assembly (August 6, 2014, if adjournment sine die is on May 7,
4 2014); except that, if a referendum petition is filed pursuant to section 1
5 (3) of article V of the state constitution against this act or an item, section,
6 or part of this act within such period, then the act, item, section, or part
7 will not take effect unless approved by the people at the general election
8 to be held in November 2014 and, in such case, will take effect on the
9 date of the official declaration of the vote thereon by the governor.

10 (2) This act applies to license plates issued or renewed on or after
11 January 1, 2015.
