**A BILL FOR AN ACT**

101     **CONCERNING PENALTIES FOR PERSONS WHO DRIVE WHILE UNDER THE**  
102             **INFLUENCE OF ALCOHOL OR DRUGS, AND, IN CONNECTION**  
103             **THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

In any DUI prosecution, if at the time of driving or within a reasonable time thereafter, the driver's blood contains 5 nanograms or more of delta 9-tetrahydrocannabinol per milliliter in whole blood, as shown by analysis of the defendant's blood, such fact gives rise to a

permissible inference that the defendant was under the influence of one or more drugs.

Under current law, in any prosecution for vehicular homicide or vehicular assault, if at the time of the commission of the alleged offense, or within a reasonable time thereafter, as shown by analysis of the defendant's blood or breath, there was 0.08 or more grams of alcohol per 100 milliliters of blood, or if there was at such time 0.08 or more grams of alcohol per 210 liters of breath, it is presumed that the defendant was under the influence of alcohol. The bill removes this presumption and states instead that such fact gives rise to a permissible inference that the defendant was under the influence of alcohol.

The bill removes instances of the term "habitual user" from the traffic code.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-4-1301, **amend**  
3 (1) (d), (2) (b), (4), and (6) (e); **repeal** (1) (c); and **add** (6) (a) (IV) as  
4 follows:

5 **42-4-1301. Driving under the influence - driving while**  
6 **impaired - driving with excessive alcoholic content - definitions -**  
7 **penalties.** (1) (c) ~~It is a misdemeanor for any person who is an habitual~~  
8 ~~user of any controlled substance defined in section 18-18-102 (5), C.R.S.,~~  
9 ~~to drive a motor vehicle, vehicle, or low-power scooter in this state.~~

10 (d) ~~For the purposes of this subsection (1)~~ AS USED IN THIS  
11 SECTION, one or more drugs ~~shall mean all substances defined as a~~ MEANS  
12 ANY drug, AS DEFINED in section 27-80-203 (13), C.R.S., ~~and all~~  
13 ~~controlled substances~~ ANY CONTROLLED SUBSTANCE, AS defined in  
14 section 18-18-102 (5), C.R.S., ~~and glue-sniffing, aerosol inhalation, and~~  
15 ~~the inhalation of~~ any INHALED GLUE, AEROSOL, OR other toxic vapor or  
16 vapors, AS DEFINED IN SECTION 18-18-412, C.R.S.

17 (2) (b) In any prosecution for the offense of DUI per se, the  
18 defendant shall be entitled to offer direct and circumstantial evidence to

1 show that there is a disparity between what ~~the~~ ANY tests show and other  
2 facts so that the trier of fact could infer that the tests were in some way  
3 defective or inaccurate. Such evidence may include testimony of  
4 nonexpert witnesses relating to the absence of any or all of the common  
5 symptoms or signs of intoxication for the purpose of impeachment of the  
6 accuracy of the analysis of the person's blood or breath.

7 (4) No court shall accept a plea of guilty to a non-alcohol-related  
8 or non-drug-related traffic offense or guilty to the offense of UDD from  
9 a person charged with DUI OR DUI per se; ~~or habitual user~~; except that  
10 the court may accept a plea of guilty to a non-alcohol-related or  
11 non-drug-related traffic offense or to UDD upon a good faith  
12 representation by the prosecuting attorney that the attorney could not  
13 establish a prima facie case if the defendant were brought to trial on the  
14 original alcohol-related or drug-related offense.

15 (6) (a) In any prosecution for DUI or DWAI, the defendant's BAC  
16 OR DRUG CONTENT at the time of the commission of the alleged offense  
17 or within a reasonable time thereafter gives rise to the following  
18 presumptions or inferences:

19 (IV) IF AT SUCH TIME THE DRIVER'S BLOOD CONTAINED FIVE  
20 NANOGRAMS OR MORE OF DELTA 9-TETRAHYDROCANNABINOL PER  
21 MILLILITER IN WHOLE BLOOD, AS SHOWN BY ANALYSIS OF THE  
22 DEFENDANT'S BLOOD, SUCH FACT GIVES RISE TO A PERMISSIBLE INFERENCE  
23 THAT THE DEFENDANT WAS UNDER THE INFLUENCE OF ONE OR MORE  
24 DRUGS.

25 (e) **Involuntary blood test - admissibility.** Evidence acquired  
26 through an involuntary blood test pursuant to section 42-4-1301.1 (3)  
27 shall be admissible in any prosecution for DUI, DUI per se, DWAI,

1 ~~habitual user~~, or UDD, and in any prosecution for criminally negligent  
2 homicide pursuant to section 18-3-105, C.R.S., vehicular homicide  
3 pursuant to section 18-3-106 (1) (b), C.R.S., assault in the third degree  
4 pursuant to section 18-3-204, C.R.S., or vehicular assault pursuant to  
5 section 18-3-205 (1) (b), C.R.S.

6 **SECTION 2.** In Colorado Revised Statutes, 18-3-106, **amend** (1)  
7 (b) (II), (2) introductory portion, and (2) (c); and **add** (2) (d) as follows:

8 **18-3-106. Vehicular homicide.** (1) (b) (II) For the purposes of  
9 this subsection (1), one or more drugs ~~shall mean all substances defined~~  
10 ~~as a~~ MEANS ANY drug, AS DEFINED in section 27-80-203 (13), C.R.S., and  
11 ~~all controlled substances~~ ANY CONTROLLED SUBSTANCE, AS defined in  
12 section 18-18-102 (5), and ~~glue-sniffing, aerosol inhalation, or the~~  
13 ~~inhalation of~~ any INHALED GLUE, AEROSOL, OR other toxic vapor or

5 (b) (II), (2) introductory portion, and (2) (c); and **add** (2) (d) as follows:

6 18-3-205. **Vehicular assault.** (1) (b) (II) For the purposes of this  
7 subsection (1), one or more drugs shall mean all substances defined as a  
8 MEANS ANY drug, AS DEFINED in section 27-80-203 (13), C.R.S., and all  
9 controlled substances ANY CONTROLLED SUBSTANCE, AS defined in  
10 section 18-18-102 (5), and ~~glue-sniffing, aerosol inhalation, or the~~  
11 ~~inhalation~~ of any INHALED GLUE, AEROSOL, OR other toxic vapor or  
12 vapors, as defined in section 18-18-412.

13 (2) In any prosecution for a violation of subsection (1) of this  
14 section, the amount of alcohol in the defendant's blood or breath at the  
15 time of the commission of the alleged offense, or within a reasonable time  
16 thereafter, as shown by analysis of the defendant's blood or breath, shall

2 **SECTION 4.** In Colorado Revised Statutes, 42-1-102, **repeal**  
3 (41.7) as follows:

4 **42-1-102. Definitions.** As used in articles 1 to 4 of this title,  
5 unless the context otherwise requires:

6 (41.7) "~~Habitual user~~" shall incorporate by reference the offense  
7 ~~described in section 42-4-1301 (1) (c).~~

8 **SECTION 5.** In Colorado Revised Statutes, 42-2-121, **amend** (2)  
9 (b) and (5) (a) (III) as follows:

10 **42-2-121. Records to be kept by department - admission of**  
11 **records in court.** (2) (b) The department shall also keep a separate file  
12 of all abstracts of court records of dismissals of DUI, DUI per se, DWAI,  
13 ~~habitual user~~, and UDD charges and all abstracts of records in cases  
14 where the original charges were for DUI, DUI per se, DWAI, ~~habitual~~  
15 ~~user~~, and UDD and the convictions were for nonalcohol- or  
16 nondrug-related traffic offenses. This file shall be made available only to  
17 criminal justice agencies, as defined in section 24-72-302 (3), C.R.S.

18 (5) (a) Upon application by a person, the department shall  
19 expunge all records concerning a conviction of a person for UDD with a  
20 BAC of at least 0.02 but not more than 0.05 and any records concerning  
21 an administrative determination resulting in a revocation under section  
22 42-2-126 (3) (b) or (3) (e) if:

23 (III) The person has not been convicted for any other DUI, DUI  
24 per se, DWAI, ~~habitual user~~, or UDD offense that was committed while  
25 such person was under twenty-one years of age and is not subject to any  
26 other administrative determination resulting in a revocation under section  
27 42-2-126 for any other occurrence while such person was under

1 twenty-one years of age;

2 **SECTION 6.** In Colorado Revised Statutes, **amend** 42-2-129 as  
3 follows:

4 **42-2-129. Mandatory surrender of license or permit for**  
5 **driving under the influence or with excessive alcoholic content.** Upon  
6 a plea of guilty or nolo contendere, or a verdict of guilty by the court or  
7 a jury, to DUI, OR DUI per se, ~~or habitual user~~, or, for a person under  
8 twenty-one years of age, to DUI, DUI per se, DWAI, ~~habitual user~~, or  
9 UDD, the court shall require the offender to immediately surrender the  
10 offender's driver's, minor driver's, or temporary driver's license or  
11 instruction permit to the court. The court shall forward to the department  
12 a notice of plea or verdict, on the form prescribed by the department,  
13 together with the offender's license or permit, not later than ten days after  
14 the surrender of the license or permit. Any person who does not  
15 immediately surrender the license or permit to the court, except for good  
16 cause shown, commits a class 2 misdemeanor traffic offense.

17 **SECTION 7.** In Colorado Revised Statutes, 42-2-125, **amend** (1)  
18 (b), (1) (g), and (1) (i) as follows:

19 **42-2-125. Mandatory revocation of license and permit.** (1) The  
20 department shall immediately revoke the license or permit of any driver  
21 or minor driver upon receiving a record showing that such driver has:

22 (b) Been convicted of driving a motor vehicle while under the  
23 influence of a controlled substance, as defined in section 18-18-102 (5),  
24 C.R.S.; ~~or while an habitual user of such a controlled substance;~~

25 (g) (I) Been twice convicted of any combination of DUI, DUI per  
26 se, OR DWAI ~~or habitual user~~ for acts committed within a period of five  
27 years;

1 (II) In the case of a minor driver, been convicted of DUI, DUI per  
2 se, OR DWAI ~~or habitual user~~ committed while such driver was under  
3 twenty-one years of age;

4 (i) Been convicted of DUI, DUI per se, OR DWAI ~~or habitual user~~  
5 and has two previous convictions of any of such offenses. The license of  
6 any driver shall be revoked for an indefinite period and shall only be  
7 reissued upon proof to the department that said driver has completed a  
8 level II alcohol and drug education and treatment program certified by the  
9 unit in the department of human services that administers behavioral  
10 health programs and services, including those related to mental health and  
11 substance abuse, pursuant to section 42-4-1301.3 and that said driver has  
12 demonstrated knowledge of the laws and driving ability through the  
13 regular motor vehicle testing process. In no event shall such license be  
14 reissued in less than two years.

15 **SECTION 8.** In Colorado Revised Statutes, 42-2-127, **amend** (1)  
16 (a) and (6) (b); and **repeal** (5) (b) (II) as follows:

17 **42-2-127. Authority to suspend license - to deny license - type**  
18 **of conviction - points.** (1) (a) Except as provided in paragraph (b) of  
19 subsection (8) of this section, the department has the authority to suspend  
20 the license of any driver who, in accordance with the schedule of points  
21 set forth in this section, has been convicted of traffic violations resulting  
22 in the accumulation of twelve points or more within any twelve  
23 consecutive months or eighteen points or more within any twenty-four  
24 consecutive months, or, in the case of a minor driver eighteen years of age  
25 or older, who has accumulated nine points or more within any twelve  
26 consecutive months, or twelve points or more within any twenty-four  
27 consecutive months, or fourteen points or more for violations occurring



1 after reaching the age of eighteen years, or, in the case of a minor driver  
2 under the age of eighteen years, who has accumulated more than five  
3 points within any twelve consecutive months or more than six points for  
4 violations occurring prior to reaching the age of eighteen years; except  
5 that the accumulation of points causing the subjection to suspension of  
6 the license of a chauffeur who, in the course of employment, has as a  
7 principal duty the operation of a motor vehicle shall be sixteen points in  
8 one year, twenty-four points in two years, or twenty-eight points in four  
9 years, if all the points are accumulated while said chauffeur is in the  
10 course of employment. Any provision of this section to the contrary  
11 notwithstanding, the license of a chauffeur who is convicted of DUI, DUI  
12 per se, DWAI, ~~habitual user~~, UDD, or leaving the scene of an accident  
13 shall be suspended in the same manner as if the offense occurred outside  
14 the course of employment. Whenever a minor driver under the age of  
15 eighteen years receives a summons for a traffic violation, the minor's  
16 parent or legal guardian or, if the minor is without parents or guardian,  
17 the person who signed the minor driver's application for a license shall  
18 immediately be notified by the court from which the summons was  
19 issued.

23 (6) (b) For the purposes of this article, a plea of no contest  
24 accepted by the court or the forfeiture of any bail or collateral deposited  
25 to secure a defendant's appearance in court or the failure to appear in  
26 court by a defendant charged with DUI, DUI per se, ~~habitual user~~, or  
27 UDD who has been issued a summons and notice to appear pursuant to

1 section 42-4-1707 as evidenced by records forwarded to the department  
2 in accordance with the provisions of section 42-2-124 shall be considered  
3 as a conviction.

4 **SECTION 9.** In Colorado Revised Statutes, 42-2-132, **amend** (2)  
5 (a) (III) and (2) (a) (IV) as follows:

6 **42-2-132. Period of suspension or revocation.** (2) (a) (III) In the  
7 case of a minor driver whose license has been revoked as a result of one  
8 conviction for DUI, DUI per se, DWAI, ~~habitual user~~, or UDD, the minor  
9 driver, unless otherwise required after an evaluation made pursuant to  
10 section 42-4-1301.3, must complete a level I alcohol and drug education  
11 program certified by the unit in the department of human services that  
12 administers behavioral health programs and services, including those  
13 related to mental health and substance abuse.

14 (IV) Any person whose license or privilege to drive a motor  
15 vehicle on the public highways has been revoked under section 42-2-125  
16 (1) (g) (I) or (1) (i) or 42-2-203 where the revocation was due in part to  
17 a DUI, DUI per se, OR DWAI ~~or habitual user~~ conviction shall be  
18 required to present an affidavit stating that the person has obtained at the  
19 person's own expense a signed lease agreement for the installation and  
20 use of an approved ignition interlock device, as defined in section  
21 42-2-132.5 (9) (a), in each motor vehicle on which the person's name  
22 appears on the registration and any other vehicle that the person may  
23 drive during the period of the interlock-restricted license.

24 **SECTION 10.** In Colorado Revised Statutes, 42-2-132.5, **amend**  
25 (1) (a), (1) (c), and (4) (c) as follows:

26 **42-2-132.5. Mandatory and voluntary restricted licenses**  
27 **following alcohol convictions - rules.** (1) **Persons required to hold an**

1 **interlock-restricted license.** The following persons shall be required to  
2 hold an interlock-restricted license pursuant to this section for at least one  
3 year following reinstatement prior to being eligible to obtain any other  
4 driver's license issued under this article:

5 (a) A person whose privilege to drive was revoked for multiple  
6 convictions for any combination of a DUI, DUI per se, OR DWAI ~~or~~  
7 ~~habitual user~~ pursuant to section 42-2-125 (1) (g) (I) or (1) (i);

8 (c) A person whose privilege to drive was revoked as an habitual  
9 offender under section 42-2-203 in which the revocation was due in part  
10 to a DUI, DUI per se, OR DWAI ~~or habitual user~~ conviction; or

11 (4) **Persons who may acquire an interlock-restricted license**  
12 **prior to serving a full-term revocation.** (c) In order to be eligible for  
13 early reinstatement pursuant to this subsection (4), a person who has been  
14 designated an habitual offender under the provisions of section 42-2-202  
15 must have at least one conviction for DUI, DUI per se, OR DWAI ~~or~~  
16 ~~habitual user~~ under section 42-4-1301, and no contributing violations  
17 other than violations for driving under restraint under section 42-2-138  
18 or reckless driving under section 42-4-1401.

19 **SECTION 11.** In Colorado Revised Statutes, 42-2-138, **amend**  
20 (1) (a) and (1) (d) as follows:

21 **42-2-138. Driving under restraint - penalty.** (1) (a) Any person  
22 who drives a motor vehicle or off-highway vehicle upon any highway of  
23 this state with knowledge that the person's license or privilege to drive,  
24 either as a resident or a nonresident, is under restraint for any reason other  
25 than conviction of DUI, DUI per se, DWAI, ~~habitual user~~, or UDD is  
26 guilty of a misdemeanor. A court may sentence a person convicted of this  
27 misdemeanor to imprisonment in the county jail for a period of not more

1 than six months and may impose a fine of not more than five hundred  
2 dollars.

3 (d) (I) A person who drives a motor vehicle or off-highway  
4 vehicle upon any highway of this state with knowledge that the person's  
5 license or privilege to drive, either as a resident or nonresident, is  
6 restrained under section 42-2-126 (3), is restrained solely or partially  
7 because of a conviction of DUI, DUI per se, DWAI, ~~habitual user~~, or  
8 UDD, or is restrained in another state solely or partially because of an  
9 alcohol-related driving offense is guilty of a misdemeanor and, upon  
10 conviction thereof, shall be punished by imprisonment in the county jail  
11 for not less than thirty days nor more than one year and, in the discretion  
12 of the court, by a fine of not less than five hundred dollars nor more than  
13 one thousand dollars. Upon a second or subsequent conviction, the person  
14 shall be punished by imprisonment in the county jail for not less than  
15 ninety days nor more than two years and, in the discretion of the court, by  
16 a fine of not less than five hundred dollars nor more than three thousand  
17 dollars. The minimum county jail sentence imposed by this subparagraph  
18 (I) shall be mandatory, and the court shall not grant probation or a  
19 suspended sentence thereof; but, in a case where the defendant is  
20 convicted although the defendant established that he or she had to drive  
21 the motor vehicle in violation of this subparagraph (I) because of an  
22 emergency, the mandatory jail sentence, if any, shall not apply, and, for  
23 a first conviction, the court may impose a sentence of imprisonment in the  
24 county jail for a period of not more than one year and, in the discretion of  
25 the court, a fine of not more than one thousand dollars, and, for a second  
26 or subsequent conviction, the court may impose a sentence of  
27 imprisonment in the county jail for a period of not more than two years

1 and, in the discretion of the court, a fine of not more than three thousand  
2 dollars.

3 (II) In any trial for a violation of subparagraph (I) of this  
4 paragraph (d), a duly authenticated copy of the record of the defendant's  
5 former convictions and judgments for DUI, DUI per se, DWAI, ~~habitual~~  
6 ~~user~~, or UDD or an alcohol-related offense committed in another state  
7 from any court of record or a certified copy of the record of any denial or  
8 revocation of the defendant's driving privilege under section 42-2-126 (3)  
9 from the department shall be prima facie evidence of the convictions,  
10 judgments, denials, or revocations and may be used in evidence against  
11 the defendant. Identification photographs and fingerprints that are part of  
12 the record of the former convictions, judgments, denials, or revocations  
13 and the defendant's incarceration after sentencing for any of the former  
14 convictions, judgments, denials, or revocations shall be prima facie  
15 evidence of the identity of the defendant and may be used in evidence  
16 against the defendant.

17 **SECTION 12.** In Colorado Revised Statutes, 42-2-202, **amend**  
18 (2) (a) (I) as follows:

19 **42-2-202. Habitual offenders - frequency and type of**  
20 **violations.** (2) (a) An habitual offender is a person having three or more  
21 convictions of any of the following separate and distinct offenses arising  
22 out of separate acts committed within a period of seven years:

23 (I) DUI, DUI per se, OR DWAI; ~~or habitual user~~;

24 **SECTION 13.** In Colorado Revised Statutes, 42-2-405, **amend**  
25 (3) (a) as follows:

26 **42-2-405. Driver's license disciplinary actions - grounds for**  
27 **denial - suspension - revocation - disqualification.** (3) For purposes of

1 the imposition of restraints and sanctions against commercial driving  
2 privileges:

3 (a) A conviction for DUI, DUI per se, OR DWAI, ~~or habitual user,~~  
4 or a substantially similar law of any other state pertaining to drinking and  
5 driving, or an administrative determination of a violation of section  
6 42-2-126 (3) (a) or (3) (b) shall be deemed driving under the influence;  
7 and

8 **SECTION 14.** In Colorado Revised Statutes, 42-4-1301.1,  
9 **amend** (2) (a) (I) and (2) (b) (I) as follows:

10 **42-4-1301.1. Expressed consent for the taking of blood, breath,**  
11 **urine, or saliva sample - testing.** (2) (a) (I) A person who drives a  
12 motor vehicle upon the streets and highways and elsewhere throughout  
13 this state shall be required to take and complete, and to cooperate in the  
14 taking and completing of, any test or tests of the person's breath or blood  
15 for the purpose of determining the alcoholic content of the person's blood  
16 or breath when so requested and directed by a law enforcement officer  
17 having probable cause to believe that the person was driving a motor  
18 vehicle in violation of the prohibitions against DUI, DUI per se, DWAI,  
19 ~~habitual user,~~ or UDD. Except as otherwise provided in this section, if a  
20 person who is twenty-one years of age or older requests that the test be a

26 person's breath shall be obtained and tested, except as provided in

1 (b) (I) Any person who drives any motor vehicle upon the streets  
2 and highways and elsewhere throughout this state shall be required to  
3 submit to and to complete, and to cooperate in the completing of, a test  
4 or tests of such person's blood, saliva, and urine for the purpose of  
5 determining the drug content within the person's system when so  
6 requested and directed by a law enforcement officer having probable  
7 cause to believe that the person was driving a motor vehicle in violation  
8 of the prohibitions against DUI, OR DWAI ~~or habitual user~~ and when it  
9 is reasonable to require such testing of blood, saliva, and urine to  
10 determine whether such person was under the influence of, or impaired
