The bill creates the Colorado premature birth commission (commission). The executive director of the department of public health and environment (director) is required to appoint no more than 12 members to the commission. The commission is directed to make recommendations and identify strategies to reduce premature births in

Colorado. The bill requires the director to report these findings to the health committees of the general assembly. The commission is repealed after the report is made.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 25-1-128 as
3 follows:

4 **25-1-128. Prematurity birth commission - creation - legislative**
5 **declaration - members - purpose - repeal.** (1) THE GENERAL ASSEMBLY
6 FINDS AND DECLARES THAT:

7 (a) PREMATURE BIRTH IS THE LEADING CAUSE OF NEWBORN
8 DEATHS;

9 (b) CHILDREN BORN PREMATURELY HAVE HIGHER RATES OF
10 LEARNING DISABILITIES, CEREBRAL PALSY, SENSORY DEFICITS, AND
11 RESPIRATORY ILLNESSES COMPARED TO CHILDREN BORN AT FULL TERM;

12 (c) ONE IN TEN COLORADO BABIES IS BORN PREMATURE;

13 (d) SIGNIFICANT RACIAL, ETHNIC, GEOGRAPHIC, AND
14 SOCIOECONOMIC DISPARITIES IN THE RATE OF BABIES BORN PREMATURE
15 PERSIST IN COLORADO;

16 (e) PREMATURE BIRTH IS COSTLY TO BUSINESSES AND
17 GOVERNMENT AGENCIES, WITH THE MEDICAL COSTS TO EMPLOYERS
18 INCREASING UP TO SEVENTY-FIVE PERCENT WITH A PREMATURETY
19 DIAGNOSIS; AND

20 (f) TO REDUCE THE INCIDENCE OF PREMATURE BIRTHS IN
21 COLORADO, PREVENTIVE STRATEGIES SHOULD INVOLVE IDENTIFYING AND
22 STRENGTHENING EXISTING COMPREHENSIVE EVIDENCE-BASED APPROACHES
23 WHILE, AT THE SAME TIME, CONSIDERING NEW AND PROMISING
24 APPROACHES TO PREVENTION OF PREMATURE BIRTHS.

1 (2) (a) THERE IS HEREBY CREATED THE COLORADO PREMATURE
2 BIRTH COMMISSION, REFERRED TO IN THIS SECTION AS THE COMMISSION.

3 (b) ON OR BEFORE JULY 1, 2014, THE EXECUTIVE DIRECTOR OF THE
4 DEPARTMENT, IN CONSULTATION WITH A COLORADO NONPROFIT
5 ORGANIZATION WHOSE MISSION FOCUS IS PRIMARILY PREMATURE BIRTH
6 ISSUES, SHALL APPOINT NO MORE THAN THIRTEEN MEMBERS TO THE
7 COMMISSION WITH THE GOAL OF SELECTING A BROAD REPRESENTATION OF
8 INDIVIDUALS WHO WORK IN THE MATERNAL AND CHILD HEALTH FIELD. THE
9 COMMISSION MUST INCLUDE FOUR MEMBERS OF THE GENERAL ASSEMBLY.
10 THE SPEAKER OF THE HOUSE, THE MINORITY LEADER OF THE HOUSE, THE
11 SENATE PRESIDENT, AND THE SENATE MINORITY LEADER WILL EACH CHOOSE
12 ONE OF THE FOUR MEMBERS TO SERVE ON THE COMMISSION. THE FOUR
13 MEMBERS OF THE GENERAL ASSEMBLY CHOSEN FOR THE COMMISSION
14 SHALL NOT BE COMPENSATED BY THE STATE FOR THEIR SERVICE ON THE
15 COMMISSION. IN MAKING THE APPOINTMENTS, THE EXECUTIVE DIRECTOR
16 OF THE DEPARTMENT SHALL CONSIDER:

17 (I) STATE AGENCIES AND NONPROFIT ORGANIZATIONS IN CHARGE
18 OF SYSTEMS AND SERVICES FOR THE BETTERMENT OF THE HEALTH,
19 EDUCATION, AND WELFARE OF WOMEN, INFANTS, AND CHILDREN;

20 (II) REPRESENTATIVES OF THE PUBLIC HEALTH COMMUNITY;

21 (III) ETHNIC, RACIAL, AND GEOGRAPHIC DIVERSITY AMONG THE
22 APPOINTED MEMBERS;

23 (IV) HEALTH CARE PROVIDERS FOR WOMEN, INFANTS, AND
24 CHILDREN;

25 (V) INDIVIDUALS WHO HAVE BEEN DIRECTLY AFFECTED BY
26 PREMATURE BIRTH; AND

27 (VI) A REPRESENTATIVE FROM AN ASSOCIATION OF COLORADO

1 HOSPITALS.

3 (c) THE COMMISSION SHALL MEET AT LEAST ONCE AND NO LATER
4 THAN JULY 31, 2014. AT THE FIRST MEETING, THE COMMISSION MEMBERS
5 SHALL ELECT A CHAIRPERSON WHO SHALL ACT AS THE PRESIDING OFFICER
6 OF THE COMMISSION, DETERMINE A MEETING SCHEDULE, AND GUIDE THE
7 DEVELOPMENT OF RECOMMENDATIONS AND STRATEGIES TO REDUCE
8 PREMATURE BIRTHS. THE COMMISSION MEMBERS SHALL SERVE WITHOUT
9 COMPENSATION AND WITHOUT REIMBURSEMENT FOR EXPENSES.

10 (3) (a) ON OR BEFORE DECEMBER 1, 2014, THE COMMISSION SHALL
11 MAKE RECOMMENDATIONS AND IDENTIFY STRATEGIES TO REDUCE
12 PREMATURE BIRTHS IN COLORADO. THE RECOMMENDATIONS MAY INCLUDE
13 STATUTORY CHANGES FOR CONSIDERATION BY THE GENERAL ASSEMBLY,
14 POLICY CHANGES, EDUCATIONAL EFFORTS, OR OTHER RECOMMENDATIONS.

15 (b) ON OR BEFORE JANUARY 31, 2015, THE EXECUTIVE DIRECTOR
16 OF THE DEPARTMENT SHALL REPORT THE COMMISSION'S
17 RECOMMENDATIONS AND SUGGESTED STRATEGIES TO THE SENATE HEALTH
18 AND HUMAN SERVICES COMMITTEE; THE HOUSE HEALTH, INSURANCE, AND
19 ENVIRONMENT COMMITTEE; AND THE HOUSE PUBLIC HEALTH CARE AND
20 HUMAN SERVICES COMMITTEE, OR THEIR SUCCESSOR COMMITTEES.

21 (4) THIS SECTION IS REPEALED, EFFECTIVE FEBRUARY 1, 2015.

22 **SECTION 2. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
