**A BILL FOR AN ACT**

101 **CONCERNING REQUESTS FOR MULTIPLE BOOKING PHOTOGRAPHS.**

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law requires a person requesting a copy of a booking photograph to sign a statement at the time that the request is made. The bill authorizes a custodian of the photographs to allow a person to sign the statement once for all booking photographs requested for a specified period of time not to exceed one year.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-72-305.5, **amend**  
3 (2) (b) as follows:

4 **24-72-305.5. Access to records - denial by custodian - use of**  
5 **records to obtain information for solicitation - definitions.** (2) (b) A  
6 person who requests a copy of a ONE OR MORE booking ~~photograph~~  
7 PHOTOGRAPHS from an official custodian shall, at the time of making the  
8 request, submit the statement required by subsection (1) of this section;  
9 EXCEPT THAT A CUSTODIAN MAY ALLOW A PERSON WHO ANTICIPATES  
10 MAKING MULTIPLE REQUESTS FOR BOOKING PHOTOGRAPHS TO SUBMIT THE  
11 REQUIRED STATEMENT ONCE FOR ALL BOOKING PHOTOGRAPHS REQUESTED  
12 DURING A SPECIFIED PERIOD OF TIME NOT TO EXCEED ONE YEAR. By  
13 signing the statement, the person is affirming that ~~the~~ ANY booking  
14 photograph OBTAINED FROM THE CUSTODIAN will not be placed in a  
15 publication or posted to a web site that requires the payment of a fee or  
16 other exchange for pecuniary gain in order to remove or delete the  
17 booking photograph from the publication or web site.

18 **SECTION 2. Applicability.** This act applies to request for  
19 photographs made on or after the effective date of this act.

20 **SECTION 3. Safety clause.** The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, and safety.
