Bill Summary

Sunset Process - House Agriculture, Livestock and Natural Resources Committee. The bill continues indefinitely the natural areas council, which serves as an advisory council to the parks and wildlife commission, in accordance with the recommendation of the department of regulatory agencies contained in its sunset review of the council.

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 33-33-113 as
3 follows:

4 **33-33-113. Legislative review - termination.** (1) The council
5 ~~shall be terminated~~ TERMINATES on ~~July 1, 2014~~ SEPTEMBER 1, 2024,
6 unless the general assembly votes to renew the legislative mandate of this
7 article. Absent a vote to renew the legislative mandate of this article, the
8 council shall cease all operations within a twelve-month period after ~~July~~
9 ~~1, 2014~~ SEPTEMBER 1, 2024.

10 (2) Prior to ~~said~~ THE termination, ~~such~~ THE DEPARTMENT OF
11 REGULATORY AGENCIES SHALL REVIEW THE advisory committee ~~shall be~~
12 ~~reviewed~~ as provided for in section 2-3-1203, C.R.S.

13 **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)
14 (aa) (II); and **add** (3) (kk) as follows:

15 **2-3-1203. Sunset review of advisory committees.** (3) The
16 following dates are the dates for which the statutory authorization for the
17 designated advisory committees is scheduled for repeal:

26 **SECTION 3. Effective date.** This act takes effect July 1, 2014.

1 **SECTION 4. Safety clause.** The general assembly hereby finds,
2 determines, and declares that this act is necessary for the immediate
3 preservation of the public peace, health, and safety.
