A BILL FOR AN ACT

101 **CONCERNING GRANTS FOR DOMESTIC WASTEWATER TREATMENT**
102 **PLANTS TO COMPLY WITH THE WATER QUALITY CONTROL**
103 **COMMISSION'S NUTRIENTS MANAGEMENT CONTROL**
104 **REGULATION, AND, IN CONNECTION THEREWITH, MAKING AN**

grant fund and directs the division of administration in the department of public health and environment to award grants from the fund to local governments pursuant to rules promulgated by the water quality control commission for the planning, design, construction, or improvement of domestic wastewater treatment works owned or operated by a local government that are needed to comply with the commission's nutrients management control regulation. The fund is repealed on September 1, 2016.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 25-8-608.5 as
3 follows:

4 **25-8-608.5. Nutrients grant fund - rules - repeal.** (1) THE
5 NUTRIENTS GRANT FUND IS HEREBY CREATED IN THE STATE TREASURY.
6 MONEYS IN THE FUND, INCLUDING INTEREST EARNED ON THE INVESTMENT
7 OF MONEYS IN THE FUND, ARE CONTINUOUSLY APPROPRIATED TO THE
8 DEPARTMENT FOR THE PURPOSE SPECIFIED IN SUBSECTION (2) OF THIS
9 SECTION.

10 (2) (a) THE DIVISION SHALL EXPEND MONEYS IN THE FUND TO
11 AWARD GRANTS TO LOCAL GOVERNMENTS FOR THE PLANNING, DESIGN,
12 CONSTRUCTION, OR IMPROVEMENT OF DOMESTIC WASTEWATER
13 TREATMENT WORKS OWNED OR OPERATED BY A LOCAL GOVERNMENT
14 THAT ARE NEEDED TO COMPLY WITH THE COMMISSION'S NUTRIENTS
15 MANAGEMENT CONTROL REGULATION.

16 (b) THE DIVISION MAY RETAIN UP TO ONE HUNDRED THOUSAND
17 DOLLARS PER FISCAL YEAR OF THE MONEYS IN THE FUND TO COVER THE
18 COST OF ADMINISTERING THE PROJECTS OR GRANTS UNDER THIS SECTION.

19 (3) THE COMMISSION SHALL PROMULGATE RULES IN ACCORDANCE
20 WITH ARTICLE 4 OF TITLE 24, C.R.S., AS NECESSARY TO ADMINISTER THIS
21 SECTION, INCLUDING RULES DEFINING WHO IS ELIGIBLE FOR GRANTS AND

1 THE CRITERIA TO BE USED IN AWARDING GRANTS. THE CRITERIA MUST
2 GIVE PRIORITY TO APPLICANTS THAT HAVE THE LOWEST FINANCIAL
3 ABILITY TO PAY FOR THE NECESSARY CONSTRUCTION OR IMPROVEMENTS.
4 THE RULES MAY BE INCORPORATED INTO AND PROMULGATED AS AN
5 AMENDMENT TO THE RULES PROMULGATED UNDER SECTION 25-8-608
6 (1.7).

7 (4) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2016.

8 **SECTION 2. Appropriation.** In addition to any other
9 appropriation, there is hereby appropriated, out of any moneys in the
10 general fund not otherwise appropriated, to the department of public
11 health and environment, for the fiscal year beginning July 1, 2013, the
12 sum of \$15,000,000, or so much thereof as may be necessary, for
13 allocation to the nutrients grant fund created in section 25-8-608.5 (1),
14 Colorado Revised Statutes, related to the implementation of this act.

15 **SECTION 3. Safety clause.** The general assembly hereby finds,
16 determines, and declares that this act is necessary for the immediate
17 preservation of the public peace, health, and safety.
