A BILL FOR AN ACT

101 **CONCERNING THE ADVANCED PLACEMENT INCENTIVES PILOT**
102 **PROGRAM, AND, IN CONNECTION THEREWITH, MAKING AN**
103 **APPROPRIATION.**

Bill Summary

The bill extends the advanced placement incentives pilot program (pilot program) for 3 years to 2021.

The bill requires the department of education to report the number of students in the pilot program who enrolled in advanced placement courses during the prior school year and to collect disaggregated data

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-95-102, **amend**
3 (4); and **add** (5) as follows:

4 **22-95-102. Advanced placement incentives pilot program -**
5 **creation - administration - teacher incentives - reporting.** (4) ~~On or~~
6 ~~before December 1, 2014,~~ The department shall develop and make
7 available guidelines for participation in the pilot program.

8 (5) (a) ON OR BEFORE AUGUST 15, 2018, AND ON OR BEFORE
9 AUGUST 15 EACH YEAR THEREAFTER, THE DEPARTMENT SHALL:

10 (I) REPORT THE NUMBER OF STUDENTS IN THE PILOT PROGRAM
11 WHO ENROLLED IN AN ADVANCED PLACEMENT COURSE DURING THE PRIOR
12 SCHOOL YEAR IN EACH PARTICIPATING SCHOOL DISTRICT, BY COURSE;

13 (II) COLLECT THE FOLLOWING DISAGGREGATED DATA FROM THE
14 ADVANCED PLACEMENT EXAM VENDOR TO CAPTURE THE PERFORMANCE
15 OF STUDENTS ON END-OF-COURSE ADVANCED PLACEMENT EXAMS DURING
16 THE PRIOR SCHOOL YEAR:

17 (A) THE NUMBER OF STUDENTS IN THE PILOT PROGRAM WHO TOOK
18 END-OF-COURSE ADVANCED PLACEMENT EXAMS IN EACH PARTICIPATING
19 SCHOOL DISTRICT, BY COURSE; AND

20 (B) THE NUMBER OF STUDENTS IN THE PILOT PROGRAM WHO
21 SCORED THREE OR ABOVE ON END-OF-COURSE ADVANCED PLACEMENT
22 EXAMS IN EACH PARTICIPATING SCHOOL DISTRICT, BY COURSE.

23 (b) ON OR BEFORE NOVEMBER 15, 2019, AND ON OR BEFORE
24 NOVEMBER 15, 2020, THE DEPARTMENT SHALL PREPARE AND SUBMIT TO

1 THE JOINT BUDGET COMMITTEE AND TO THE MEMBERS OF THE EDUCATION
2 COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND THE SENATE, OR
3 ANY SUCCESSOR COMMITTEES, A REPORT CONCERNING THE PILOT
4 PROGRAM. THE REPORT MUST INCLUDE THE INFORMATION COLLECTED BY
5 THE DEPARTMENT PURSUANT TO SUBSECTION (5)(a) OF THIS SECTION, AS
6 WELL AS DATA ON THE NUMBER AND AMOUNT OF FINANCIAL INCENTIVES
7 DISTRIBUTED TO EACH PARTICIPATING SCHOOL DISTRICT THROUGH THE
8 PILOT PROGRAM.

9 **SECTION 2.** In Colorado Revised Statutes, **amend** 22-95-104 as
10 follows:

11 **22-95-104. Notice by department of upcoming repeal.** On or
12 before October 30, ~~2017~~ 2020, but not earlier than October 1, ~~2017~~ 2020,
13 the department shall provide a notice of the pilot program's upcoming
14 ~~2018~~ 2021 repeal date to the members of the education committees of the
15 house of representatives and the senate, or any successor committees.

16 **SECTION 3.** In Colorado Revised Statutes, **amend** 22-95-105 as
17 follows:

18 **22-95-105. Repeal of article.** This ~~article~~ ARTICLE 95 is repealed,
19 effective July 1, ~~2018~~ 2021.

20 **SECTION 4. Appropriation.** For the 2018-19 state fiscal year,
21 \$260,937 is appropriated to the department of education. This
22 appropriation is from the state education fund created in section 17 (4)(a)
23 of article IX of the state constitution and is based on an assumption that
24 the department will require an additional 0.3 FTE. To implement this act,
25 the department may use this appropriation for the advanced placement
26 incentives pilot program.

27 **SECTION 5. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
