101 **CONCERNING THE AUTHORITY OF THE DEPARTMENT OF REVENUE TO**  
102 **ALLOW LICENSED PRIVATE INVESTIGATORS ACCESS TO CERTAIN**  
103 **MOTOR VEHICLE RECORDS FOR SPECIFIED PURPOSES.**

**Bill Summary**

The bill allows for access to information on driver's licenses and motor vehicle registrations to licensed private investigators, licensed private investigative agencies, and licensed security services. This change conforms state law to the federal "Driver's Privacy Protection Act of

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 24-72-204, **amend**  
3 (7) (b) introductory portion and (7) (b) (VIII) as follows:

4           **24-72-204. Allowance or denial of inspection - grounds -**  
5 **procedure - appeal - definitions.** (7) (b) Notwithstanding the provisions  
6 of paragraph (a) of this subsection (7), only upon obtaining a completed  
7 requestor release form under section 42-1-206 (1) (b), C.R.S., the  
8 department may allow inspection of the information referred to in  
9 paragraph (a) of this subsection (7) for the following uses:

10           (VIII) For use by any PRIVATE INVESTIGATOR LICENSED PURSUANT  
11 TO SECTION 12-58.5-105, C.R.S., LICENSED private investigative agency,  
12 or LICENSED security service for any purpose permitted under this  
13 paragraph (b);

14           **SECTION 2. Act subject to petition - effective date.** This act  
15 takes effect at 12:01 a.m. on the day following the expiration of the  
16 ninety-day period after final adjournment of the general assembly (August  
17 8, 2012, if adjournment sine die is on May 9, 2012); except that, if a  
18 referendum petition is filed pursuant to section 1 (3) of article V of the  
19 state constitution against this act or an item, section, or part of this act  
20 within such period, then the act, item, section, or part will not take effect  
21 unless approved by the people at the general election to be held in  
22 November 2012 and, in such case, will take effect on the date of the  
23 official declaration of the vote thereon by the governor.
