A BILL FOR AN ACT CONCERNING THE CONTINUATION OF THE REGULATION OF CUSTOM MEAT PROCESSORS, AND, IN CONNECTION THEREWITH, IMPLEMENTING THE RECOMMENDATIONS OF THE 2017 SUNSET REPORT OF THE DEPARTMENT OF REGULATORY AGENCIES.

Bill Summary

Sunset Process - House Agriculture, Livestock, and Natural Resources Committee. The bill implements the recommendations of the department of regulatory agencies in its sunset review and report on the

"Custom Processing of Meat Animals Act" (act) by:

- ! Extending the act for 13 years; and
- ! Authorizing custom meat processors licensed under the act to sell poultry to retail food establishments.

This article ARTICLE 33 is repealed. 21 effective July 1, 2018. Prior to such SEPTEMBER 1, 2031.
