"Custom Processing of Meat Animals Act" (act) by:
! Extending the act for 13 years; and
! Authorizing custom meat processors licensed under the act to sell poultry to retail food establishments.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-104, **repeal**
3 (14)(a)(IV); and **add** (24)(a)(V) as follows:

4 **24-34-104. General assembly review of regulatory agencies**
5 **and functions for repeal, continuation, or reestablishment - legislative**
6 **declaration - repeal.** (14) (a) The following agencies, functions, or both,
7 are scheduled for repeal on July 1, 2018:

8 (IV) ~~The regulation by the department of agriculture of the custom~~
9 ~~processing of meat animals in accordance with article 33 of title 35,~~
10 ~~C.R.S.;~~

11 (24) (a) The following agencies, functions, or both, are scheduled
12 for repeal on September 1, 2023:

13 (V) THE REGULATION OF THE CUSTOM PROCESSING OF MEAT
14 ANIMALS BY THE DEPARTMENT OF AGRICULTURE IN ACCORDANCE WITH
15 ARTICLE 33 OF TITLE 35.

16 **SECTION 2.** In Colorado Revised Statutes, **amend** 35-33-407 as
17 follows:

18 **35-33-407. Repeal of article.** This ~~article~~ ARTICLE 33 is repealed,
19 effective ~~July 1, 2018.~~ ~~Prior to such~~ SEPTEMBER 1, 2023. BEFORE ITS
20 repeal, the licensing functions of the department ~~shall be reviewed as~~
21 ~~provided for in~~ ARE SCHEDULED FOR REVIEW IN ACCORDANCE WITH
22 section 24-34-104. ~~C.R.S.~~

23 **SECTION 3.** In Colorado Revised Statutes, 35-33-301, **amend**

1 (1) as follows:

2 **35-33-301. Sale of poultry - labeling - rules.** (1) A poultry
3 producer ~~licensed or~~ exempted under this ~~article~~ ARTICLE 33 may sell
4 poultry to individuals. A POULTRY PRODUCER LICENSED UNDER THIS
5 ARTICLE 33 MAY SELL POULTRY TO RETAIL FOOD ESTABLISHMENTS
6 LICENSED PURSUANT TO SECTION 25-4-1606 AND TO INDIVIDUALS.

7 **SECTION 4. Effective date.** This act takes effect July 1, 2018.

8 **SECTION 5. Safety clause.** The general assembly hereby finds,
9 determines, and declares that this act is necessary for the immediate
10 preservation of the public peace, health, and safety.
