**A BILL FOR AN ACT**

101      **CONCERNING MEASURES TO SUPPORT THE IN-DEMAND CAREER**  
102              **WORKFORCE, AND, IN CONNECTION THEREWITH, MAKING AN**  
103              **APPROPRIATION.**

**Bill Summary**

The bill directs the state board of community colleges and occupational education (board) to administer the in-demand short-term credentials program (program) in order to support the expansion of the number of available and qualified professionals who are able to meet Colorado's in-demand workforce needs.

The bill appropriates \$38.6 million from the general fund for this program. The board is required to allocate funds to community and technical colleges, area technical colleges, local district colleges, and Colorado Mesa university to provide assistance to students for eligible expenses that support their enrollment in eligible programs. If unexpended resources exist, the funds must be used to pay for a student's housing, transportation, or food expenses.

The bill requires the office of future work to provide grants to registered apprenticeship programs that provide training in the building and construction trade at no cost to apprentices. The bill appropriates \$1.4 million from the general fund for this grant program.

The bill appropriates \$5 million from the general fund to create 2 new short-term degree nursing programs at community or technical colleges.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly  
3 finds and declares that:

4 (a) Colorado has significant workforce demands in various  
5 industries, including early childhood education, education, law  
6 enforcement, fire and forestry, construction, and nursing;

7 (b) These industries support other industries across the economy  
8 and have a positive return on public investment because: All Coloradans  
9 benefit from the availability of child care and education so that they may  
10 work while knowing their children are safe and cared for; that the  
11 foundational infrastructure is secure through high-quality construction;  
12 that fundamental public services are provided through fire protection,  
13 forest management, and law enforcement; and that people have access to  
14 quality health care;

15 (c) According to labor market index data, Colorado has an  
16 opportunity to scale these industries because demand for these industries  
17 is projected to grow based on recent patterns suggesting an average of ten

1 to fifteen percent annual increase in these industry jobs;

2 (d) These in-demand industries have significant job openings:

3 (I) The education sector consistently has approximately five  
4 thousand job openings, which openings have been exacerbated by  
5 professionals leaving the sector because of industry pressures and the  
6 COVID-19 pandemic;

7 (II) The nursing sector consistently has approximately twenty  
8 thousand job openings;

9 (III) Job openings in the construction sector are anticipated to  
10 double because of the historic federal investment in infrastructure and  
11 electrification; and

12 (IV) The early childhood sector, the fire and forestry sector, and  
13 the law enforcement sector each have approximately one thousand job  
14 openings;

15 (e) Investment in postsecondary education and training that leads  
16 to careers in these industries demonstrates to Coloradans that these  
17 professions are a priority for the state and that supporting enrollment in  
18 educational and training programs will ensure a qualified workforce with  
19 limited debt and a clear path to employment;

20 (f) The state's investment in the in-demand short-term credentials  
21 program is intended to support twenty thousand students pursuing  
22 credentials in these industries; and

23 (g) The extraordinary demand for short-term education and  
24 training in nursing exceeds the state's current capacity to meet the  
25 demand. The state's investment in increasing the capacity is intended to  
26 support the training of two hundred additional nurses annually.

19 TOTAL AND DISAGGREGATED BY ANY FACTORS DETERMINED BY THE  
20 BOARD; AND

21 (IV) IF AVAILABLE, EMPLOYMENT AND EARNINGS OUTCOMES FOR  
22 STUDENTS AWARDED FUNDS PURSUANT TO THE PROGRAM, IN TOTAL AND  
23 DISAGGREGATED BY ANY FACTORS DETERMINED BY THE BOARD.

24 (b) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), THE  
25 REPORTING REQUIREMENT IN THIS SUBSECTION (7) CONTINUES  
26 INDEFINITELY.

27 (8) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE

1 REQUIRES:

2 (a) "ELIGIBLE EXPENSES" MEANS TUITION, FEES, BOOKS,  
3 MATERIALS, OR SUPPLIES FOR ELIGIBLE PROGRAMS.

4 (b) "ELIGIBLE INSTITUTION" MEANS A COMMUNITY OR TECHNICAL  
5 COLLEGE DESCRIBED IN SECTION 23-60-205, AN AREA TECHNICAL COLLEGE  
6 DEFINED IN SECTION 23-60-103 (1), A LOCAL DISTRICT COLLEGE DEFINED  
7 IN SECTION 23-71-102 (1), AND COLORADO MESA UNIVERSITY  
8 ESTABLISHED PURSUANT TO SECTION 23-53-101.

9 (c) "ELIGIBLE PROGRAM" MEANS AN IN-DEMAND CREDENTIAL IN  
10 EARLY CHILDHOOD, EDUCATION, LAW ENFORCEMENT, FIRE AND FORESTRY,  
11 CONSTRUCTION, OR NURSING THAT IS TWO YEARS OR LESS IN DURATION.

12 (d) "PROGRAM" MEANS THE IN-DEMAND SHORT-TERM  
13 CREDENTIALS PROGRAM DESCRIBED IN SUBSECTION (1) OF THIS SECTION.

14 (9) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2027.

22 (1)(a) THERE IS CREATED IN THE OFFICE OF THE FUTURE OF WORK WITHIN  
23 THE DEPARTMENT OF LABOR AND EMPLOYMENT THE CONSTRUCTION  
24 REGISTERED APPRENTICESHIP GRANT PROGRAM TO PROVIDE GRANTS TO  
25 REGISTERED APPRENTICESHIP PROGRAMS IN THE BUILDING AND  
26 CONSTRUCTION TRADES THAT PROVIDE TRAINING AT NO COST TO  
27 APPRENTICES.

1 (b) THE OFFICE SHALL CONSULT WITH THE OFFICE OF ECONOMIC  
2 DEVELOPMENT, THE DEPARTMENT OF EDUCATION, THE DEPARTMENT OF  
3 HIGHER EDUCATION, THE STATE BOARD FOR COMMUNITY COLLEGES AND  
4 OCCUPATIONAL EDUCATION, LOCAL DISTRICT COLLEGES, THE WORK FORCE  
5 DEVELOPMENT COUNCIL, AND AREA TECHNICAL COLLEGES IN THE

11 PROGRAMS IN THE BUILDING AND CONSTRUCTION TRADES AS GRANT  
12 RECIPIENTS. A GRANT RECIPIENT MUST SATISFY, AT A MINIMUM, THE  
13 FOLLOWING CRITERIA:

14 (I) TRAIN APPRENTICES IN THE BUILDING AND CONSTRUCTION  
15 TRADES;

16 (II) AS A PART OF ITS GRANT APPLICATION, DEMONSTRATE HOW IT  
17 WILL USE THE GRANT AWARD TO PROVIDE TRAINING TO APPRENTICES AT  
18 NO COST TO THE APPRENTICES;

19 (III) AS A PART OF ITS GRANT APPLICATION, DEMONSTRATE HOW

21 REMOVE BARRIERS TO ACCESSING TRAINING, TO PERSONS FROM TARGET  
22 POPULATIONS;

23 (IV) AS A PART OF ITS GRANT APPLICATION, COMMIT TO  
24 DIVERSITY, EQUITY, AND INCLUSION IN ITS REGISTERED APPRENTICESHIP  
25 PROGRAM; AND

26 (V) AS PART OF ITS GRANT APPLICATION, PROVIDE ANY OTHER  
27 CRITERIA OR ADDITIONAL INFORMATION DETERMINED NECESSARY BY THE



1 DEPARTMENT OF LABOR AND EMPLOYMENT.

2 (b) THE OFFICE SHALL DEVELOP PERFORMANCE EXPECTATIONS FOR  
3 GRANT RECIPIENTS. THE OFFICE OF THE FUTURE OF WORK MAY TERMINATE  
4 A REGISTERED APPRENTICESHIP PROGRAM'S PARTICIPATION IN THE GRANT  
5 PROGRAM IF THE REGISTERED APPRENTICESHIP PROGRAM FAILS TO SATISFY  
6 THE PERFORMANCE EXPECTATIONS.

7 (c) THE OFFICE SHALL DEVELOP A SCALE FOR THE AMOUNT OF  
8 MONEY TO BE AWARDED TO GRANT RECIPIENTS BASED UPON FACTORS

8 **report.** (1) (b) (I) For the 2010-11 fiscal year and for fiscal years  
9 beginning on or after July 1, 2016, the general assembly shall make  
10 annual appropriations of general fund money, of cash funds received from  
11 tuition income, and of money that is estimated to be received by an  
12 institution, under the direction and control of the governing board, as  
13 stipends, as defined in section 23-18-102, and through fee-for-service

19 THE GENERAL FUND TO ESTABLISH TWO NEW SHORT-TERM DEGREE  
20 NURSING PROGRAMS AT COMMUNITY OR TECHNICAL COLLEGES DESCRIBED  
21 IN SECTION 23-60-205. THE FUNDS MUST BE USED FOR THE FOLLOWING  
22 PURPOSES, AS APPLICABLE, TO SUPPORT THE EXPANSION OF SHORT-TERM  
23 DEGREE NURSING PROGRAMS:

24 (a) NEW SHORT-TERM DEGREE PROGRAM CURRICULUM  
25 DEVELOPMENT;

26 (b) NEW SHORT-TERM DEGREE PROGRAM EQUIPMENT AND  
27 SUPPLIES;

1 (c) NEW SHORT-TERM DEGREE PROGRAM IMPLEMENTATION,  
2 INCLUDING ACCREDITATION COSTS; AND

3 (d) NEW SHORT-TERM DEGREE ADMINISTRATION COSTS, INCLUDING  
4 REPORTING.

5 (2) ANY UNEXPENDED MONEY REMAINING AT THE END OF THE  
6 2023-24 STATE FISCAL YEAR FROM THE APPROPRIATION PURSUANT TO  
7 SUBSECTION (1) OF THIS SECTION:

8 (a) DOES NOT REVERT TO THE GENERAL FUND OR ANY OTHER  
9 FUND;

10 (b) MAY BE USED BY THE DEPARTMENT OF HIGHER EDUCATION IN  
11 THE 2024-25 OR 2025-26 STATE FISCAL YEAR WITHOUT FURTHER  
12 APPROPRIATION; AND

13 (c) MUST NOT BE USED FOR ANY PURPOSE OTHER THAN THE  
14 PURPOSES SET FORTH IN THIS SECTION.

15 (3) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2027.

16 **SECTION 7.** In Colorado Revised Statutes, 25-1.5-102, **amend**  
17 (1)(e) as follows:

18 **25-1.5-102. Epidemic and communicable diseases - powers and**  
19 **duties of department - rules - definitions.** (1) The department has, in  
20 addition to all other powers and duties imposed upon it by law, the  
21 powers and duties provided in this section as follows:

22 (e) For fiscal year 2022-23, the general assembly shall appropriate  
23 ten million dollars from the economic recovery and relief cash fund  
24 created in section 24-75-228 to the department. The department shall use  
25 this appropriation for recruitment and re-engagement efforts of workers  
26 in the health-care profession with current or expired licenses and staffing.  
27 ANY MONEY REMAINING AT THE END OF THE 2022-23 STATE FISCAL YEAR

1 FROM THIS APPROPRIATION IS FURTHER APPROPRIATED TO THE  
2 DEPARTMENT FOR THE PURPOSES OF THIS SECTION. ANY MONEY THAT IS  
3 NOT EXPENDED OR OBLIGATED BY DECEMBER 30, 2024, REVERTS TO THE  
4 "AMERICAN RESCUE PLAN ACT OF 2021" CASH FUND CREATED IN SECTION  
5 24-75-226 (2) IN ACCORDANCE WITH SECTION 24-75-226 (4)(d). ANY  
6 MONEY OBLIGATED BY DECEMBER 30, 2024, MUST BE EXPENDED BY  
7 DECEMBER 31, 2026.

8 **SECTION 8.** In Colorado Revised Statutes, 25-1.5-406, **amend**  
9 (9) as follows:

10 **25-1.5-406. School nurse grant program - creation - eligibility**  
11 **- award of grants - rules - report - legislative declaration - definitions.**

12 (9) The general assembly shall appropriate three million dollars from the  
13 economic recovery and relief cash fund created in section 24-75-228 to  
14 the department for the GRANT program. ANY MONEY REMAINING AT THE  
15 END OF THE 2022-23 STATE FISCAL YEAR FROM THIS APPROPRIATION IS  
16 FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE PURPOSES OF THIS  
17 SECTION. ANY MONEY THAT IS NOT EXPENDED OR OBLIGATED BY  
18 DECEMBER 30, 2024, REVERTS TO THE "AMERICAN RESCUE PLAN ACT OF  
19 2021" CASH FUND CREATED IN SECTION 24-75-226 (2) IN ACCORDANCE  
20 WITH SECTION 24-75-226 (4)(d) . ANY MONEY OBLIGATED BY DECEMBER  
21 30, 2024, MUST BE EXPENDED BY DECEMBER 31, 2026.

22 **SECTION 9. Appropriation.** (1) For the 2023-24 state fiscal  
23 year, \$43,600,000 is appropriated to the department of higher education  
24 for allocation to the state board for community colleges and occupational  
25 education. This appropriation is from the general fund. To implement this  
26 act, the board may use this appropriation as follows:

27 (a) \$38,600,000 for the in-demand short-term credentials program;

1 and

2 (b) \$5,000,000 for short-term degree nursing programs.

3 (2) For the 2023-24 state fiscal year, \$1,400,000 is appropriated  
4 to the department of labor and employment. This appropriation is from  
5 the general fund, and is based on an assumption that the department will  
6 require an additional 1.2 FTE. To implement this act, the department may  
7 use this appropriation for the construction registered apprenticeship grant  
8 program administered by the office of the future of work.

9 **SECTION 10. Safety clause.** The general assembly hereby finds,  
10 determines, and declares that this act is necessary for the immediate  
11 preservation of the public peace, health, or safety.
