**Bill Summary**

**Sunset Process - House Business Affairs and Labor Committee.** This bill implements the recommendations of the department of regulatory agencies in its sunset review of the workers' compensation classification appeals board by continuing the board until 2021.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 8-55-105 (1), Colorado Revised Statutes, is  
3 amended to read:

4 **8-55-105. Repeal of article.** (1) This article is repealed, effective  
5 July 1, ~~2010~~ 2021.

6 **SECTION 2. Repeal.** 24-34-104 (41) (i), Colorado Revised  
7 Statutes, is repealed as follows:

8 **24-34-104. General assembly review of regulatory agencies  
9 and functions for termination, continuation, or reestablishment.**

10 (41) The following agencies, functions, or both, shall terminate on July  
11 1, 2010:

12 (i) ~~The workers' compensation classification appeals board,  
13 created by article 55 of title 8, C.R.S.;~~

14 **SECTION 3.** 24-34-104, Colorado Revised Statutes, is amended  
15 BY THE ADDITION OF A NEW SUBSECTION to read:

16 **24-34-104. General assembly review of regulatory agencies  
17 and functions for termination, continuation, or reestablishment.**

18 (52) THE FOLLOWING AGENCIES, FUNCTIONS, OR BOTH, SHALL TERMINATE  
19 ON JULY 1, 2021: THE WORKERS' COMPENSATION CLASSIFICATION  
20 APPEALS BOARD, CREATED IN ARTICLE 55 OF TITLE 8, C.R.S.

21 **SECTION 4. Safety clause.** The general assembly hereby finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, and safety.
