
A BILL FOR AN ACT

101	CONCERNING FUNDING FOR SYSTEM CAPACITY CHANGES RELATED TO
102	INTELLECTUAL AND DEVELOPMENTAL DISABILITIES WAIVER
103	SERVICES, AND, IN CONNECTION THEREWITH, MAKING AND
104	REDUCING APPROPRIATIONS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <u>http://www.leg.state.co.us/billsummaries.</u>)

Joint Budget Committee. The bill amends the intellectual and developmental disabilities cash fund to allow moneys in the fund to be







used for administrative expenses relating to medicaid waiver renewal and redesign and for increasing system capacity for home- and community-based services for persons with intellectual and developmental disabilities.

On or before a certain date, the bill requires the department of health care policy and financing (state department) and providers to develop a plan for distributing moneys appropriated for increases in system capacity and to report to the joint budget committee regarding the plan. The state department shall then distribute moneys appropriated for increases in system capacity pursuant to the plan. On or before a certain date, providers receiving moneys for increases in system capacity shall report to the state department concerning the use and effectiveness of the expenditures.

Additionally, the bill requires the state department and providers to report to the general assembly at the annual hearing concerning the intellectual and developmental disabilities waiting list and concerning the use of moneys for increases to system capacity.

Finally, the bill makes mid-year adjustments to funding for the intellectual and developmental disabilities waivers and appropriates moneys from the general fund to the intellectual and developmental disabilities cash fund.

1 Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 25.5-10-207, amend

3 (1.5), (2), and (3); and **add** (3.5) as follows:

25.5-10-207. Services and supports - waiting list reduction -

5 cash fund - repeal. (1.5) The state treasurer shall transfer to the 6 INTELLECTUAL AND developmental disabilities services cash fund any 7 available moneys that are appropriated by the general assembly for a 8 fiscal year for adult comprehensive services, adult supported living 9 services, children's extensive support services, and family support 10 services for persons with intellectual and developmental disabilities 11 provided pursuant to this article or part 4 of article 6 of this title that are 12 unexpended and unencumbered at the end of a fiscal year.

13 (2) During each regular session of the general assembly, the joint

1 budget committee and the health and human services committees of the 2 senate and the house of representatives, or any successor committees, 3 shall hold a joint hearing and take public testimony on the status of the 4 waiting lists for adult comprehensive services, adult supported living 5 services, children's extensive support services, and family support 6 services for persons with intellectual and developmental disabilities and 7 the availability of general fund moneys to reduce the number of persons 8 on the waiting lists and the amount of time eligible persons wait for such 9 services. ADDITIONALLY, THE STATE DEPARTMENT, 10 COMMUNITY-CENTERED BOARDS, AND PROVIDERS SHALL REPORT ON THE 11 USE AND EFFECTIVENESS OF ANY MONEYS APPROPRIATED IN THE 12 PRECEDING STATE FISCAL YEAR FOR INCREASING SYSTEM CAPACITY. The 13 goal of the hearing shall be to propose an appropriation from the general 14 fund to the intellectual and developmental disabilities services cash fund. 15 (3) The general assembly may annually appropriate moneys in the 16 intellectual and developmental disabilities services cash fund to the state 17 department for:

(a) Program costs for adult comprehensive services, adult
supported living services, children's extensive support services, and

20 Department of Human Services, County Administration, County Administration; and Adult Assistance Programs, Adult Protective Services, Adult Protective Services -- It is the intent of the General Assembly that any amount in the Adult Protective Services line item that is not required for the provision of adult protective services may be transferred to the County Administration line item and used to provide additional benefits under that program. - 22 Department of Human Services, County Administration, County Incentive Payments; Office of Self Sufficiency, Colorado Works Program, County Block Grants; Child Support Enforcement, Child Support Enforcement -- It is the intent of the General Assembly that, pursuant to Sections 26-13-108 and 26-13-112.5 (2), C.R.S., the Department distribute child support incentive payments to counties. It is further the intent of the General Assembly that all of the State share of recoveries of amounts of support for public assistance recipients, less annual appropriations from this fund source for state child support enforcement operations, be distributed to counties, as described in Section 26-13-108, C.R.S. 24 Department of Human Services, Division of Child Welfare, Child Welfare Services -- It is the intent of the General Assembly that the Department may hold out up to \$1,000,000 total funds in this line item for activities designed to maximize Colorado's receipt of federal funds under Title IV-E of the Social Security Act. Expenditures may include, but need not be limited to, distributions to counties for Title-IV-E-related administrative costs, incentive payments to counties for improved Title IV-E claiming, automated system changes, and/or purchase of contract services designed to help the State in maximizing Title IV-E receipts.

- 25 Department of Human Services, Division of Child Welfare, Family and Children's Programs -- It is the intent of the General Assembly that \$4,006,949 of the funds appropriated for this line item be used to assist county departments of social services in implementing and expanding family- and community-based services for adolescents. It is the intent of the General Assembly that such services be based on a program or programs that have been demonstrated to be effective in reducing the need for higher cost residential services.
- 26 Department of Human Services, Office of Self Sufficiency, Colorado Works Program, County Block Grants -- Pursuant to Sections 26-2-714 (7) and 26-2-714 (9), C.R.S., under certain conditions, a county may transfer federal Temporary Assistance for Needy Families (TANF) funds within its Colorado Works Program Block Grant to the federal child care development fund or to programs funded by Title XX of the federal Social Security Act. One of the conditions specified is that the amount a county transfers must be specified by the Department of Human Services as being available for transfer within the limitation imposed by federal law. It is the intent of the General Assembly that the Department allow individual counties to transfer a greater percent of federal TANF funds than the state is allowed under federal law as long as: (a) Each county has had an opportunity to transfer an amount up to the federal maximum allowed; and, (b) the total amount transferred statewide does not exceed the federal maximum.

It is further the intent of the General Assembly that any amount in the home care allowance program line item that is unused may be transferred to the home care allowance grant program line item and used to provide additional benefits under that program.
- 35 Department of Human Services, Adult Assistance Programs, Community Services for the Elderly, Older Americans Act Programs, and State Funding for Senior Services -- Amounts in the Older Americans Act Programs line item are calculated based on a requirement for a non-federal match of at least 15 percent, including a 5.0 percent state match, pursuant to Title III of the federal Older Americans Act. The Department is authorized to transfer General Fund and cash funds from the State Funding for Senior Services line item to the Older Americans Act Programs line item to comply with the 5.0 percent state match requirement for the Older Americans Act Programs. This appropriation is based on the assumption that all federal Title III funds requiring a state match that are not for purposes of administration or included in the appropriations for other line items will be expended from the Older Americans Act Programs line item.

1 SECTION 4. Appropriation. In addition to any other 2 appropriation, there is hereby appropriated, out of any moneys in the 3 general fund not otherwise appropriated, to the department of health care 4 policy and financing, for the fiscal year beginning July 1, 2013, the sum 5 of \$4,500,000, or so much thereof as may be necessary, for allocation to 6 the intellectual and developmental disabilities services cash fund created 7 in section 25.5-10-207 (1), Colorado Revised Statutes, related to the 8 implementation of this act.

9 **SECTION 5.** Appropriation. (1) In addition to any other 10 appropriation, there is hereby appropriated, to the department of health 11 care policy and financing, for the fiscal year beginning July 1, 2013, the 12 sum of \$13,852 and 0.2 FTE, or so much thereof as may be necessary, for 13 allocation to the division of intellectual and developmental disabilities for 14 administrative expenses for renewal and redesign of medicaid home- and 15 community-based services waivers relating to intellectual and 16 developmental disabilities. Of said sum, \$6,926(M) is from the 17 intellectual and developmental disabilities services cash fund created in 18 section 25.5-10-207 (1), Colorado Revised Statutes, and \$6,926 is from 19 federal funds.

20 In addition to any other appropriation, there is hereby (2)21 appropriated, to the department of health care policy and financing, for 22 the fiscal year beginning July 1, 2013, the sum of \$400,000, or so much 23 thereof as may be necessary, for allocation to the division of intellectual 24 and developmental disabilities for contract services for renewal and 25 redesign of medicaid home- and community-based services waivers 26 relating to intellectual and developmental disabilities. Of said sum, 27 \$200,000(M) is from the intellectual and developmental disabilities

services cash fund created in section 25.5-10-207 (1), Colorado Revised
Statutes, and \$200,000 is from federal funds. Any moneys appropriated
in this subsection (2) not expended prior to July 1, 2014, are further
appropriated to the department for the fiscal year beginning July 1, 2014,
for the same purposes.

6 In addition to any other appropriation, there is hereby (3) 7 appropriated, out of any moneys in the intellectual and developmental 8 disabilities services cash fund created in section 25.5-10-207 (1), 9 Colorado Revised Statutes, not otherwise appropriated, to the department 10 of health care policy and financing, for the fiscal year beginning July 1, 11 2013, the sum of \$4,293,074, or so much thereof as may be necessary, for 12 allocation to the division of intellectual and developmental disabilities for 13 increasing system capacity for home- and community-based intellectual 14 and developmental disabilities programs, services, and supports. Any 15 moneys appropriated in this subsection (3) not expended prior to July 1, 16 2014, are further appropriated to the department for the fiscal year 17 beginning July 1, 2014, for the same purposes.

SECTION 6. Effective date. This act takes effect upon passage;
except that sections 1, 4, and 5 of this act take effect March 1, 2014.

SECTION 7. Safety clause. The general assembly hereby finds,
 determines, and declares that this act is necessary for the immediate
 preservation of the public peace, health, and safety.
