A BILL FOR AN ACT

101 CONCERNING CHANGING THE MAXIMUM JAIL SENTENCE FOR CERTAIN 102 CRIMES FROM ONE YEAR TO THREE HUNDRED SIXTY-FOUR DAYS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

Under current law, the maximum jail sentence for a class 2 misdemeanor, misdemeanors without a fixed statutory penalty, and municipal ordinance violations is one year. The bill changes the maximum jail sentence to 364 days.

3	18-1.3-505. Penalty for misdemeanor not fixed by statute -

16	unless approved by the people at the general election to be held in
17	November 2018 and, in such case, will take effect on the date of the

official declaration of the vote thereon by the governor.
