Bill Summary

The bill establishes a one-time general fund transfer in the 2014-15 state fiscal year to the Colorado state fair authority cash fund for the purpose of renovating and enhancing facilities and items used in the state fair's programs with the state's 4-H clubs and the Colorado association of the national future farmers of America organization.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1. Legislative declaration.** (1) The general assembly 3 hereby finds and declares that: 4 (a) The Colorado State Fair has tremendous positive impact on the 5 state and the Pueblo community. Every year there are eleven days of 6 family activities, fun-filled events, concerts, rodeos, arts, and agriculture 7 presentations that draw thousands of people to the state and to the Pueblo 8 community. 9 (b) The Pueblo City Council intends to provide funding to the 10 Colorado State Fair in the 2015 and 2016 fiscal years, in the amount of 11 \$125,000 annually, subject to appropriation; and 12 (c) It is important that the state does whatever it can to ensure the 13 sustainability of the Colorado State Fair in Pueblo. 14 **SECTION 2.** In Colorado Revised Statutes, 35-65-107, add (4) 15 as follows: 16 35-65-107. State fair fund - lease and use of facilities - repeal. 17 (4) (a) For the 2014-15 state fiscal year, the state treasurer 18 SHALL TRANSFER THREE HUNDRED THOUSAND DOLLARS FROM THE 19 GENERAL FUND TO THE COLORADO STATE FAIR AUTHORITY CASH FUND 20 CREATED IN THIS SECTION FOR THE PURPOSE OF RENOVATING AND 21 ENHANCING FACILITIES AND ITEMS USED IN THE STATE FAIR'S PROGRAMS 22 WITH THE STATE'S 4-H CLUBS AND THE COLORADO ASSOCIATION OF THE 23 NATIONAL FUTURE FARMERS OF AMERICA ORGANIZATION.
