### A BILL FOR AN ACT

### 101 CONCERNING CONTINUING EDUCATION REQUIREMENTS FOR

102 ADMINISTRATORS OF ASSISTED LIVING FACILITIES.

### **Bill Summary**

The bill requires an operator of an assisted living facility to ensure that the administrator of the facility completes 30 hours of continuing education every 2 years. The operator must maintain records on the premises of the facility as proof of the fulfillment of the educational requirements. The department of public health and environment is required to promulgate rules concerning the educational requirements.

2 SECTION 1. In Colorado Revised Statutes, add 25-27-104.3 as
3 follows:

4 25-27-104.3. Administrators - continuing education - rules. AN 5 OPERATOR OF AN ASSISTED LIVING FACILITY SHALL ENSURE THAT THE 6 ADMINISTRATOR OF THE FACILITY COMPLETES THIRTY HOURS OF 7 CONTINUING EDUCATION EVERY TWO YEARS. THE OPERATOR SHALL 8 MAINTAIN RECORDS ON THE ASSISTED LIVING RESIDENCE PREMISES AS 9 PROOF OF FULFILLMENT OF THE EDUCATIONAL REQUIREMENTS IN A FORM 10 AND MANNER PRESCRIBED BY THE DEPARTMENT. THE DEPARTMENT SHALL 11 PROMULGATE RULES TO ESTABLISH THE CONTINUING EDUCATION 12 REQUIREMENTS, WHICH MUST INCLUDE AT LEAST ONE CREDIT HOUR FOR 13 ETHICS AND AT LEAST ONE CREDIT HOUR CONCERNING EMPLOYEE 14 MANAGEMENT.

15 **SECTION 2.** Act subject to petition - effective date. This act 16 takes effect at 12:01 a.m. on the day following the expiration of the 17 ninety-day period after final adjournment of the general assembly (August 18 5, 2015, if adjournment sine die is on May 6, 2015); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the 19 20 state constitution against this act or an item, section, or part of this act 21 within such period, then the act, item, section, or part will not take effect 22 unless approved by the people at the general election to be held in 23 November 2016 and, in such case, will take effect on the date of the 24 official declaration of the vote thereon by the governor.
