# **Bill Summary**

The bill grants the division of parks and wildlife the authority to acquire real property for their Garfield county administrative office and public service center in Garfield county.

| 2  | <b>SECTION 1. Legislative declaration.</b> (1) The general assembly        |
| 3  | finds that:  |
| 4  | (a) The division of parks and wildlife (division) maintains an             |
| 5  | administrative office and public service center in Garfield county. The    |
| 6  | department of natural resources owns the building and surface              |
| 7  | improvements for the benefit of the division of parks and wildlife and the |
| 8  | parks and wildlife commission, but the land on which the building and      |
| 9  | improvements are located, approximately 3.8 acres, is owned by the         |
| 10 | Colorado Wildlife Heritage Foundation. The department leases the land      |
| 11 | from the Colorado Wildlife Heritage Foundation under a ten-year lease      |
| 12 | that ends in 2020.   |
| 13 | (b) The department of natural resources also holds an agreement            |
| 14 | with the Colorado Wildlife Heritage Foundation that gives the division     |
| 15 | the option to purchase the land for a price of \$552,500 provided the      |
| 16 | option is exercised prior to September 1, 2015. The option continues after |
| 17 | that date but the purchase price for the land will be based on a market    |
| 18 | value appraisal.   |
| 19 | (c) The division believes the market value is currently in excess          |
| 20 | of \$552,500;  |
| 21 | (d) The division wishes to acquire fee title to the land in order to       |
| 22 | eliminate the need to lease the land and to eliminate the annual lease     |
| 23 | payments;  |
| 24 | (e) The Colorado Wildlife Heritage Foundation wishes to sell the           |
| 25 | land;  |
| 26 | (f) Section 33-1-105.5 (7), Colorado Revised Statutes, grants the          |

| 4  | (g) Section 33-1-102 (10), Colorado Revised Statutes, specifies               |
| 5  | that the "division" means the division of parks and wildlife and its          |
| 6  | employees, and, when necessary, allows the term to refer to the parks and     |
| 7  | wildlife commission.  |
| 8  | SECTION 2. Division of parks and wildlife authority to                        |
| 9  | acquire real property. (1) The state of Colorado, acting by and through       |
| 10 | the division of parks and wildlife, is authorized to purchase real property   |
| 11 | located on the southerly side of Interstate 70 Exit 109, in Garfield county,  |
| 12 | being a 3.792 acres tract in Section 35, Township 5 South, Range 90 West      |
| 13 | of the 6th Principal Meridian. The real property will be acquired by the      |
| 14 | division of parks and wildlife for the division's administrative office and   |
| 15 | public service center.  |
| 16 | (2) The real property may be acquired by the division of parks and            |
| 17 | wildlife for the sum of five hundred fifty-two thousand five hundred          |
| 18 | dollars (\$552,500).  |
| 19 | (3) The real property may not be subject to any restrictive                   |
| 20 | covenants, contracts, or zoning requirements that restrict public access to   |
| 21 | the property or restrict any alternative state use of the property.           |

| 23 | (4) The state controller must approve all agreements relating to              |
| 24 | the purchase of the real property prior to closing.                           |
| 25 | (5) Any title to real property received by the division of parks and          |
| 26 | wildlife will be held by the state for the benefit and use of the division of |
| 27 | parks and wildlife.   |

| 1  | <b>SECTION 3.</b> Capital construction appropriation. For the                 |
|----|---|
| 2  | 2015-16 state fiscal year, \$552,500 is appropriated to the department of     |
| 3  | natural resources for use by the division of parks and wildlife. This         |
| 4  | appropriation is from the wildlife cash fund created in section 33-1-112      |
| 5  | (1), C.R.S. To implement this act, the division of parks and wildlife may     |
| 6  | use this appropriation for capital construction related to the acquisition of |
| 7  | real property authorized in section 2 of this act.                            |
| 8  | SECTION 4. Safety clause. The general assembly hereby finds,                  |
| 9  | determines, and declares that this act is necessary for the immediate         |
| 10 | preservation of the public peace, health, and safety.                         |
