**A BILL FOR AN ACT**

101 **CONCERNING THE MEMBERSHIP OF THE COLORADO TASK FORCE ON**  
102 **DRUNK AND IMPAIRED DRIVING.**

**Bill Summary**

The interagency task force on drunk driving was established by law in 2006. The bill changes the name of the task force to the Colorado task force on drunk and impaired driving. The bill also removes the director of the division of behavioral health in the department of human services from the board and instead requires the director to appoint 2

experts in substance abuse education and treatment. The bill also designates the chairperson of the peace officers standards and training board, or the chairperson's designee, as a member of the task force. Finally, the bill requires the executive director of the department of transportation to select a representative of the retail marijuana industry to serve on the task force.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-4-1306, **amend**  
3 (1) (d), (2), (3) (a) (VI), (3) (a) (IX) introductory portion, (3) (a) (IX) (J),  
4 and (3) (a) (IX) (K); and **add** (3) (a) (IX) (L) and (3) (a) (X) as follows:

5 **42-4-1306. Colorado task force on drunk and impaired driving**  
6 **- creation.** (1) The general assembly finds and declares that:

7 (d) According to the federal national highway transportation  
8 safety administration, other states with a statewide ~~interagency~~ task force  
9 on drunk AND IMPAIRED driving have seen a decrease in incidents of  
10 drunk and impaired driving.

11 (2) There is hereby created ~~an interagency~~ THE COLORADO task  
12 force on drunk AND IMPAIRED driving, referred to in this section as the  
13 "task force". The task force shall meet regularly to investigate methods  
14 of reducing the incidents of drunk and impaired driving and develop  
15 recommendations for the state of Colorado regarding the enhancement of  
16 government services, education, and intervention to prevent drunk and  
17 impaired driving.

18 (3) (a) The task force shall consist of:

19 (VI) TWO REPRESENTATIVES APPOINTED BY the EXECUTIVE  
20 director of the ~~division of behavioral health in the~~ department of human  
21 services WITH THE FOLLOWING QUALIFICATIONS:

22 (A) ONE REPRESENTATIVE WITH EXPERTISE IN SUBSTANCE ABUSE

- 1 EDUCATION AND TREATMENT FOR DUI OR DWAI OFFENDERS; AND
- 2 (B) ONE REPRESENTATIVE WITH EXPERTISE IN PROVIDING MINORS,  
3 ADOLESCENTS, AND JUVENILE OFFENDERS WITH SUBSTANCE ABUSE  
4 TREATMENT AND RELATED SERVICES;
- 5 (IX) The following members selected ~~jointly~~ by the member  
6 serving pursuant to subparagraph (I) of this paragraph (a):
- 7 (J) A person under twenty-four years of age who is enrolled in a  
8 secondary or postsecondary school; ~~and~~
- 9 (K) A representative of a statewide organization that represents  
10 alcohol and drug addiction counselors; AND
- 11 (L) A REPRESENTATIVE OF A STATEWIDE ORGANIZATION THAT  
12 REPRESENTS PERSONS LICENSED TO SELL RETAIL MARIJUANA FOR  
13 CONSUMPTION OFF PREMISES;
- 14 (X) THE DIRECTOR OF THE PEACE OFFICERS STANDARDS AND  
15 TRAINING BOARD OR THE DIRECTOR'S DESIGNEE; AND
- 16 (XI) A RESEARCHER WHO IS APPOINTED BY A MAJORITY OF THE  
17 TASK FORCE MEMBERS AND WHO SPECIALIZES IN DRUNK AND IMPAIRED  
18 DRIVING RESEARCH.

19 **SECTION 2. Act subject to petition - effective date.** This act  
20 takes effect at 12:01 a.m. on the day following the expiration of the  
21 ninety-day period after final adjournment of the general assembly (August  
22 6, 2014, if adjournment sine die is on May 7, 2014); except that, if a  
23 referendum petition is filed pursuant to section 1 (3) of article V of the  
24 state constitution against this act or an item, section, or part of this act  
25 within such period, then the act, item, section, or part will not take effect  
26 unless approved by the people at the general election to be held in

- 1 November 2014 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
