A BILL FOR AN ACT

CONCERNING INCREASING CONSUMER ACCESS TO ELECTRIC MOTOR

VEHICLES BY ALLOWING ELECTRIC MOTOR VEHICLE

MANUFACTURERS TO SELL THEIR OWN ELECTRIC MOTOR

VEHICLES DIRECTLY TO CONSUMERS.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law states that, with certain exceptions, a motor vehicle manufacturer may not own, operate, or control any motor vehicle dealer or used motor vehicle dealer in Colorado. The bill creates a new exception that allows the ownership, operation, or control of a motor vehicle dealer by an electric motor vehicle manufacturer that engages exclusively in the sale of electric motor vehicles of the same line-make as are manufactured by the electric motor vehicle manufacturer.

An "electric motor vehicle" is a motor vehicle that operates entirely on electrical power, does not include a fuel combustion engine, and has at least 4 wheels in contact with the ground during normal operation. An "electric motor vehicle manufacturer" is an entity that manufactures and sells electric motor vehicles and does not manufacture or sell motor vehicles that are fully or partly powered by a fuel combustion engine.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 **SECTION 1.** In Colorado Revised Statutes, 44-20-102, amend 3 (14) introductory portion and (14)(b) as follows: 4 **44-20-102. Definitions.** As used in this part 1, and in part 4 of this 5 article 20, unless the context or section 44-20-402 otherwise requires: "Manufacturer" means any person, firm, association, 6 7 corporation, or trust, resident or nonresident, who THAT manufactures or 8 assembles new and unused motor vehicles; except that "manufacturer" 9 does not include: 10 (b) A person, other than a manufacturer OR AN ELECTRIC MOTOR 11 VEHICLE MANUFACTURER, AS THAT TERM IS DEFINED IN SECTION 12 44-20-126 (3)(a.6), operating a motor vehicle dealer in accordance with 13 section 44-20-126, who THAT is a licensed dealer selling motor vehicles 14 that the person has manufactured. 15 **SECTION 2.** In Colorado Revised Statutes, 44-20-126, amend 16 (2)(e) and (2)(f); and **add** (2)(g), (3)(a.3), and (3)(a.6) as follows: 17 44-20-126. Independent control of dealer - definitions -18 **exceptions.** (2) Notwithstanding subsection (1) of this section, the 19 following activities are not prohibited:

2	dealer if the manufacturer owned, operated, or controlled the used motor

13	(3) As used in this section:
14	(a.3) "ELECTRIC MOTOR VEHICLE" MEANS A MOTOR VEHICLE THAT
15	OPERATES ENTIRELY ON ELECTRICAL POWER, DOES NOT INCLUDE A FUEL
16	COMBUSTION ENGINE, AND HAS AT LEAST FOUR WHEELS IN CONTACT WITH
17	THE GROUND DURING NORMAL OPERATION.
18	(a.6) "Electric motor vehicle manufacturer" means an
19	ENTITY THAT MANUFACTURERS AND SELLS ELECTRIC MOTOR VEHICLES
20	AND DOES NOT MANUFACTURE OR SELL MOTOR VEHICLES THAT ARE FULLY
21	OR PARTLY POWERED BY A FUEL COMBUSTION ENGINE.
22	SECTION 3. Act subject to petition - effective date. This act
23	takes effect at 12:01 a.m. on the day following the expiration of the
24	ninety-day period after final adjournment of the general assembly (August
25	2, 2019, if adjournment sine die is on May 3, 2019); except that, if a
26	referendum petition is filed pursuant to section 1 (3) of article V of the
27	state constitution against this act or an item, section, or part of this act
